10. ~~(S/NF)~~ RWANDA: RWANDA'S THREE MAIN OPPOSITION PARTIES ARE CONSULTING ABOUT WHETHER TO ACCEPT A RWANDAN REBEL PROPOSAL TO MEET IN BRUSSELS IN OCTOBER. THE PARTIES AGREED ON 13 SEPTEMBER TO SUPPORT TOGETHER THE IDEA OF AN ALL-PARTY PROVISIONAL GOVERNMENT, WHICH THE RULING PARTY ON 8 SEPTEMBER HAD SAID IT COULD ACCEPT. THE OPPOSITION MAY NOW EASE DEMANDS FOR AN IMMEDIATE NATIONAL CONFERENCE. THE RULING PARTY WILL LIKELY RESIST LOSING ITS STRANGLEHOLD ON THE FRUITLESS PEACE DIALOGUE AND THE PLODDING DOMESTIC REFORM PROCESS, BUT WILL TRY TO KEEP BOTH GOING.
