4. (U) WORLDWIDE: TERRORISM NOTES.

A. ~~(S)~~ **RWANDA**: OPPOSITION POLITICAL LEADER ASSASSINATED. EMMANUEL GAPYISI, COFOUNDER AND PRESIDENT OF THE FORUM FOR PEACE AND DEMOCRACY, WAS SHOT AND KILLED AS HE DROVE TO HIS HOME IN KIGALI DURING THE EVENING OF 18 MAY. REPORTEDLY, HE WAS SHOT AT LEAST SIX TIMES BY PERSONNEL IN MILITARY UNIFORMS. THERE WAS NO INJURY TO EITHER HIS WIFE OR DRIVER. THE MURDER OF GAPYISI, SON-IN-LAW OF **RWANDA'S** FIRST PRESIDENT GREGOIRE KAYIBANDA, IS THE LATEST IN A SERIES OF ATTACKS IN THE CAPITAL WHICH HAVE INCLUDED ASSASSINATION ATTEMPTS ON OPPOSITION POLITICIANS AND UNEXPLAINED BOMBINGS. NO ONE CLAIMED RESPONSIBILITY FOR THE KILLING AND GIVEN **RWANDA'S** POOR RECORD IN PRIOR INVESTIGATIONS, THE PERPETRATORS ARE NOT LIKELY TO BE FOUND.
