(S) THE INVASION FORCE, ESTIMATED AT 175 TO 500, WAS INITIALLY SUCCESSFUL IN CAPTURING THE AIRSTRIP NEAR KAGITUMBA IN NORTHEASTERN RWANDA BUT LATER W1THDREW, POSSIBLY AS A RESULT OF THE ARRIVAL OF A FRESH RWANDAN BATTALION SENT FROM THE MILITARY CAMP AT GABARO. AN UNCONFIRMED REPORT STATED THAT THE REBELS HAVE CAPTURED A RWANDAN MILITARY CAMP IN THE NORTHEASTERN QUADRANT OF THE COUNTRY.
