2. {U} DEFENSE TERRORISM WARNING REPORT.

A. (S) ALGERIA: ALGERIAN EXTREMISTS TARGETING US INTERESTS.

{1} (C) WARNING SUMMARY: ALGERIAN EXTREMISTS HAVE CROSSED THE THRESHOLD OF SPECIFICALLY ATTACKING US INTERESTS. ON 9 NOVEMBER, SUSPECTED ALGERIAN ISLAMIC EXTREMISTS SET FIRE TO THE OFF-COMPOUND US EMBASSY WAREHOUSE IN ALGIERS, DESTROYING THE FACILITY AND ALL OF ITS CONTENTS. THE ALGERIAN GUARD ASSIGNED TO THE WAREHOUSE WAS THREATENED BECAUSE OF HIS AFFILIATION TO THE US EMBASSY BUT WAS RELEASED UNHARMED. THE PERPETRATORS KNEW THAT THE WAREHOUSE, LOCATED ABOUT THREE KILOMETERS FROM THE EMBASSY COMPOUND IN AN ISLAMIST STRONGHOLD, WAS A US FACILITY AND TARGETED IT FOR THAT REASON.

{2}-{\$} THREAT ANALYSIS: THERE IS AN INCREASED THREAT TO US INTERESTS IN ALGERIA, ESPECIALLY AS THE 16 NOVEMBER ELECTIONS APPROACH. THE PRESENCE OF US ELECTION OBSERVERS IN ALGERIA MAY HAVE PROMPTED THIS ATTACK AND COULD CERTAINLY INCITE MORE ANTI-US TERRORISM; WITH THE EXCEPTION OF A SMALL EXPLOSIVE DEVICE THROWN INTO THE US EMBASSY COMPOUND IN JANUARY OF 1992, US INTERESTS HAVE NOT BEEN SPECIFICALLY ATTACKED DURING THE ISLAMIC EXTREMISTS' MORE THAN TWO-YEAR LONG ANTI-FOREIGNER CAMPAIGN. HOWEVER, SINCE THE ARMED ISLAMIC GROUP {GIA} FIRST THREATENED FOREIGNERS IN SEPTEMBER OF 1993, REPORTS OF VARYING CREDIBILITY HAVE INDICATED THAT THE GIA INTENDED TO ATTACK US INTERESTS. ALTHOUGH NO GROUP HAS CLAIMED THE ATTACK, IT IS CONSISTENT WITH PAST ATTACKS ON FOREIGNERS IN WHICH THE EXTREMISTS STRUCK SOFT TARGETS, HAVING MINIMAL SECURITY, WHERE THERE WAS A HIGH PROBABILITY OF SUCCESS AND ESCAPE.
