HE STATED THE HISTORICAL RIGHTS OF THE BOERS TO THE OLD REPUBLICS HAD COME THROUGH THE CONQUEST OF THE MATEBELE (TRANSVAAL) AND PURCHASE (NATAL). THE AWB WAS PREPARED TO NEGOTIATE WITH THE GOVERNMENT ABOUT ITS CLAIMS AS THE LEGALLY ELECTED AUTHORITY IN POWER.

ARMED TRAINING IS CONTINUING AND A DEFENSIVE CELL STRUCTURE IS BEING CONSTRUCTED, ESPECIALLY BY THE AWB. BETWEEN AUG 90 AND JAN 91 NO LESS THAN 127 WEEKEND TRAINING COURSES WERE HELD ON FARMS IN RURAL DISTRICTS. [REDACTED] THE AWB

IS SETTING UP A JIGSAW OF 'ORDER GROUPS' WHICH ARE ORGANIZED AT AREA, REGIONAL AND DIVISION LEVELS. KOMMANDANTS AND VELDKORNETS TRAIN THE COMMANDOS WHICH ARE DEFENSIVE IN POSTURE. NEIGHBORHOOD WATCHES ARE INFILTRATED BY RIGHTISTS INTENT ON USING THEM FOR THEIR OWN POLITICAL PURPOSES. "THE AWB HAS SHOWN AN UNBELIEVABLE SURGE IN PROFILE AND IS ATTRACTING A YOUNGER AND MORE SOPHISTICATED ELEMENT". BY CONTRAST THE CP REMAINS CAUGHT UP IN THE CONFLICT OF EITHER TRYING TO BE A TRADITIONAL POLITICAL PARTY SEEKING POWER THROUGH THE BALLOT OR BREAKING WITH PARLIAMENT AND LINKING UP WITH MILITANTS IN EXTRA-PARLIAMENTARY STRUGGLE. THE FARMER'S SIEGE OF PRETORIA IN FEB 91 CAUGHT THE CP BY SURPRISE AND MAY INDICATE THE CP IS OUT OF TOUCH WITH THE RURAL RIGHT WING. WHAT THE RIGHT NEVER EXPECTED LAST YEAR WAS THE STRENGTH OF GOVERNMENT REACTION. THE SAP HAS HUNTED DOWN AND DETAINED RIGHT WINGERS IN MUCH THE SAME FASHION PREVIOUSLY USED TO CONTAIN THE LEFT.

-14 MAR 91 - AWB FREE STATE LEADER D.J. ACKERMANN AND FREE STATE CHIEF COMMANDANT A. SMITH CHALLENGE BREAKAWAY LEADER GAWIE VOLSCHENK TO A PUBLIC MEETING AND TO PROVE HIS SUPPORT AND SUBSTANTIATE HIS CLAIMS AGAINST AWB LEADER TERREBLANCHE.

-15 MAR 91 - LEADERS OF AWB "WENKOMMANDO" EXPRESS FULL CONFIDENCE IN TERREBLANCHE, IN SPITE OF STATEMENTS BY BREAK-AWAY LEADER GAWIE VOLSCHENK. FREE STATE AWB LEADER D.J. ((ACKERMANN)) AND AWB CHIEF COMMANDANT IN THE FREE STATE A. ((SMITH)) CHALLENGE VOLSCHENK TO PUBLICLY SHOW SIZE OF HIS SUPPORT.

-16 MAR 91 - AWB/ORDER BOEREVOLK/ISRAELI VISION MEMBER EUGENE ((MARAIS)) PLEADS GUILTY TO AN ATTACK ON A BUS WHICH KILLED SEVEN BLACKS. HE STATED HE SAW THE VICTIMS AS "A BUSLOAD OF ANIMALS."

-APR 91 - THE BOERE VRYHEIDSBEWEGING SAID IT WOULD ESTABLISH A "VOLK" SECURITY NETWORK (VOLKSBEVEILIGINGS NETWORK) TO COUNTER THE ANC'S SELF-DEFENSE UNITS.

-JUN 91 - ACTOR SC HALK ((JACOBSZ)) AND DEPUTY BOERESTAAT

PARTY LEADER BEN ((STRIJDOM)) ARE EXPELED FROM THE BSP ON GROUNDS THEY NEGOTIATED WITH THE ANC. BOTH DENY CHARGE AND SAY THEY ARE BEING EXPELLED DUE TO A DISPUTE OVER BSP TIES TO AN ORGANIZATION CALLED THE CHURCH OF THE CREATOR, PURPORTED TO BE A RACIST AND ATHEIST ORGANIZATION WHICH ACTIVELY ORGAINIZED AGAINST ALL RELIGION. JACOBSZ SAID HE AND STRIJDOM WERE EXPELLED BECAUSE THE BSP'S SYMPATHIES LIE WITH "THIS ANTI-CHRIST ORGANIZATION." BSP LEADER ROBERT ((VON TONDER)) SAID HE HAD EXPELLED THE TWO FOR "DISCIPLINARY REASONS" AS THEY HAD TRANSGRESSED THE PRINCIPLES OF THE BSP BY NEGOTIATING WITH THE ANC AND SACP. VON TONDER ALSO SAID JACOBSZ AND STRIJDOM HAD INSISTED THAT MEMBERS OF THE CHURCH OF THE CREATOR BE "DRIVEN FROM THE BSP," BUT THIS WAS AGAINST THE PRINCIPLES OF THE BSP AS THE PARTY STOOD FOR RELIGIOUS FREEDOM AND TOLERENCE.

-JUL 91 - SAP INVESTIGATES CLAIMS THREE MEN, ARRESTED AT THE WESTERN TRANSVAAL'S RUSTENBURG KLOOF HOTEL WITH AN AK-47 AND AMMUNITION, WERE OUT TO KILL ANDREW ((FORD)) OF THE BOERE WEERSTANDBEWEGING. POLICE ARE PROBING AN ALLEGATION THAT THE "CONTRACT" WAS ISSUED IN RETRIBUTION FOR THE DEATH OF ANOTHER RIGHTWINGER, A BODYGUARD WHO HAS APPARENTLY DISAPPEARED AND IS THOUGHT TO HAVE BEEN MURDERED. THE THREE MEN CLAIMED TO BE MEMBERS OF "ONS VEG VIR DIE BEVRYDING VAN SUID AFRIKA" (WE ARE FIGHTING FOR THE LIBERATION OF SOUTH AFRICA). POLICE ARRESTED THE GROUP ON A TIP FROM FORD, WHO CLAIMED TO BE ALERTED BY THE BOERE INTELLIGENCE SERVICE, A DIVISION OF THE BWB. FORD IS THE HEAD OF THE BOERE INTELLIGENCE SERVICE. THERE WERE ALSO UNCONFIRMED REPORTS THAT THE HEAD OF THE BOERESTAAT PARTY, ROBERT VAN TONDER, HAD ALSO RECEIVED DEATH THREATS.

-JUL 91 - HILLVIEW HIGH SCHOOL IN PRETORIA, WHICH THE GOVERNMENT HAD PLANNED TO USE TO HOUSE CHILDREN OF RETURNING ANC EXILES, IS BADLY DAMAGED BY A BOMB. TWO RIGHT-WING GROUPS, WIT WOLWE AND THE WIT REPUBLIKEINSE LEER, CLAIM RESPONSIBILITY

-9 AUG 91 - AWB MEMBERS TRYING TO GAIN ACCESS TO A NP RALLY AT VENTERSDORP, WHERE F W DEKLERK IS THE SPEAKER, CONFRONT POLICE. IN ENSUING VIOLENCE, THREE AWB MEMBERS ARE KILLED AND 50 INJURED. AWB LEADER TERREBLANCHE SAYS THE ORGANIZATION IS PREPARING FOR "REVOLUTION" BECAUSE THE GOVERNMENT CANNOT HANDLE THE SECURITY SITUATION.

-SEP 91 - AWB REJECTS A CALL FOR NEGOTIATION WITH THE ANC AND NP GOVERNMENT MADE BY ORDE BOEREVOLK LEADER NIC STRYDOM

-5 OCT 91 - AWB SPOKESMAN PIET RUDOLPH SAYS FURTHER MEETINGS WITH THE NED GEREF KERK SYNOD WOULD BE POINTLESS DUE TO THEOLOGICAL POINTS OF DIFFERENCE BETWEEN THE AWB AND THE NGK. THE AWB QUESTIONED THE PRESENCE OF A NGK SYNOD MODERATOR AT THE NATIONAL PEACE CONFERENCE. HOWEVER, BOTH GROUPS AGREED ARMED RESISTANCE AGAINST THE GOVERNMENT WAS UNACCEPTABLE.

-8 OCT 91 - CP ASKS PRESIDENT DEKLERK TO RECONSIDER PLANS FOR A MULTIPARTY CONFERENCE IN LIGHT OF ANC INSISTANCE ON EXPANDING ITS MILITARY WING, UMKHONTO WE SIZWE.

-11 OCT 91 - AWB LEADER TERREBLANCHE SAYS IF THE SAG DECLARES THE AWB AN ILLEGAL ORGANIZATION, THE AWB WILL GO UNDERGROUND AND "BLOW THE HELL OUT OF THE GOVERNMENT." HE ALSO STATED THE AWB HIGH COMMAND HAD DECIDED TO MAINTAIN ITS COMMANDOS AND INCREASE THEIR NUMBER SO THAT IT WOULD GROW INTO A "MIGHTY FORCE AND FACE MK HEADON."

-11 OCT 91 - MINISTER OF LAW AND ORDER ((KRIEL)) TELLS THE NP CAPE PARTY CONGRESS THAT THE SAP HAS UNCOVERED PLANS BY RIGHTWING GROUPS TO LAUNCH A CAMPAIGN OF VIOLENCE.

-12 OCT 91 - 400 AWB MEMBERS MARCH THROUGH VEREENING TO DEMONSTRATE RESOLVE TO FIGHT BLACK DOMINATION. THE MARCH MARKED THE END OF A THREE DAY CONFERENCE AT WHICH EUGENE TERREBLANCHE WAS REELECTED HEAD OF THE MOVEMENT. MARCHERS INCLUDED A PLATOON OF BLACK UNIFORMED MEN OF AQUILA, DESCRIBED AS THE AWB'S ELITE ("THEY'RE LIKE OUR SS, SAID THE AWB'S REGIONAL LEADER STEPH ((JACOBSON))).

-13 OCT 91 - NEWSPAPER REPORTS INDICATE RIGHT WING GROUPS HAVE BEEN PENETRATED BY GOVERNMENT INTELLIGENCE AGENCIES, AND THAT THESE AGENCIES HAD BEEN EXPLOITING DIFFERENCES IN THE RIGHTWING. CP DEPUTY LEADER FERDI ((HARTZENBERG)) ANNOUNCED THE CP HAD UNCOVERED AN INIS SPY (BELIEVED TO BE DR. J W J VILJOEN OF DELMAS WHO HAD INFILTRATED THE CP.

-28 NOV 1991 - AWB LEADER TERREBLANCHE AND FOUR MEMBERS OF HIS SUPREME COUNCIL HOLD TALKS WITH THE CHIEF MINISTER OF QWAQWA, DR. T.K. MOPELI AND CABINET MEMBERS IN PHUTHADITJHABA. MOPELI SAID THE MEETING DID NOT MEAN HE ENDORSED THE AWB'S WAY OF LIFE, AND THAT THEY DISCUSSED MATTERS OF COMMON INTEREST AND FOUND CONSIDERABLE COMMON GROUND IN SPITE OF DEEP SEATED DIFFERENCES. TERREBLANCHE SAID NATIONAL LEADERS SHOULD NEGOTIATE OVER ISSUES OF COMMON INTEREST, BUT ADDED HIS ORGANIZATION WAS PREPARED TO SHARE LAND, BUT NOT POLITICAL POWER.

-1 DEC 1991 - SEVERAL HUNDRED MEMBERS OF THE AWB MARCH THROUGH DURBAN AND TRY TO PRESENT A LETTER OF APPRECIATION TO THE SAP (THE SAP REFUSES TO ACCEPT IT). AWB LEADER EUGENE TERREBLANCHE SAYS THE ONLY WAY THE AWB WILL NEGOTIATE WITH THE ANC IS OVER THE BARREL OF A GUN.

-3 DEC 91 - KOOS ((VAN DER MERWE)) OF THE CP IS CENSURED BY HIS PARTY FOR MAKING AN UNAUTHORIZED APPEARANCE AT A NATIONAL PEACE CONFERENCE

-16 DEC 91 - AWB LEADER TERREBLANCHE WALKS OUT OF A MEETING WITH CONSTITUTIONAL DEVELOPMENT MINISTER VILJOEN, SAYING THE AWB WOULD NOT NEGOTIATE WITH "COMMUNISTS AND ANTICHRISTIANS". OTHER RIGHT WING GROUPS TO REJECT NEGOTIATION INCLUDE THE BOERESTAAT PARTY, THE BOERE VRYHEIDSBEWEGING (BVB) (ALTHOUGH IT REJECTS TERREBLANCHE AS A REPRESENTATIVE OF THE RIGHT WING). THE AFRIKANER VRYHEIDSTIGTING INDICATED IT WOULD PARTICIPATE IN CODESA

-16 DEC 91 - A FAKE BOMB IS FOUND UNDER THE ESCALATORS
LEADING TO THE EASTERN TRANSVAAL TOWN OF SABIE'S
MULTIRACIAL CINEMA COMPLEX.

-16 DEC 91 - AWB LEADER TERREBLANCHE WALKS OUT OF A
MEETING WITH CONSTITUTIONAL DEVELOPMENT MINISTER VILJOEN,
SAYING THE AWB WOULD NOT NEGOTIATE WITH "COMMUNISTS AND
ANTICHRISTIANS".

-17 DEC 91 - A GROUP OF 14 ENGLISH SPEAKING RIGHT WING
ORGANIZATIONS DESCRIBE THE NEGOTIATION PROCESS AS A
"DECLARATION OF WAR" AGAINST THOSE WHO REFUSE TO BE
SUBJECT TO COMMUNISM AND TYRANNY. THE ACTION WAS
COORDINATED BY CLIVE ((DERBY-LEWIS)) OF THE REPUBLIC UNITY
MOVEMENT OF SOUTH AFRICA, AND INCLUDES EASTERN CAPE
SETTLERS MEMORIAL ASSOCIATION, DURBAN CIVIC ACTION LEAGUE,
CONSERVATIVE ALLIANCE, PATRIOTIC FORUM, STALLARD
FOUNDATION, THINK RIGHT, SUPPORT THE POLICE ACTION GROUP,
UNIVERSITY FREEDOM OF SPEECH ASSOCIATION, YOUTH FOR SELF
DETERMINATION OF NATIONS, OWN SCHOOLS ASSOCIATION, WOMEN
FOR A SOVERIGN SOUTH AFRICA, SAVE SOUTH AFRICA AND MEGA
SOUTH AFRICA. THE STATEMENT DEMANDED THE RESIGNATION OF
THE GOVERNMENT, SAYING IT HAD NO MANDATE.

-17 DEC 91 - CP LEADER TREURNICHT CALLS FOR IMMEDIATE
SUSPENSION OF CODESA TALKS, SAYING A UNITARY MAJORITY
GOVERNMENT IN SOUTH AFRICA WOULD SUPPRESS WHITES AND LEAD

REPUBLICAN ARMY)

-19 DEC 91 - A THREAT TO "BLOW-UP" CODESA WAS ISSUED IN A
LETTER PURPORTING TO COME FROM THE WIT WOLWE. RECEIVED AT
THE PRETORIA NEWSPAPER, "THE CITIZEN" AND ADDRESSED TO
PRESIDENT DEKLERK, THE LETTER SAID "WE WILL BLOW YOUR
CODESA UP IF YOU CONTINUE WITH NEGOTIATIONS AND SELL-OUT."

-19 DEC 91 - TWENTY FIVE RIGHT WING ORGANIZATIONS PLACE AN
ADVERTISEMENT IN NEWSPAPERS SAYING CODESA IS DOOMED
BECAUSE IT DOES NOT HAVE THE SUPPORT OF THE MAJORITY OF
WHITES. THE ORGANIZATIONS ARE THE CONSERVATIVE PARTY OF
SOUTH AFRICA, DIE HERSTIGTE NASIONALE PARTY, VETERANS FOR
VICTORY, THE CIVIC ACTION LEAGUE DURBAN, DIE AFRIKANER
WEERSTANDBEWEGING, DIE ORANJE WERKERSVERENIGING, DIE
BOERE VRYHEIDSBEWEGING, THE STALLARD FOUNDATION, THE

-19 DEC 91 - BOERESTAAT PARTY LEADER ROBERT VON TONDER SAYS, "THE BOER NATION WOULD FIGHT FOR ITS FREEDOM IN ANY MANNER IT CHOOSES, INCLUDING THE OVERTHROW OF ANY RESULTS GROWING OUT OF CODESA." WHILE NOT CLAIMING LINKS WITH THE BOERE REPUBLICAN ARMY, VON TONDER SAID HE FULLY SUPPORTED THEM AND EXPECTED MORE OF THIS KIND OF ACTION. VON TONDER SAID, "THE BOER VOLK WILL REFUSE TO PARTICIPATE IN ANY FUTURE REFERENDA OR ELECTIONS WHICH MAY RESULT FROM CODESA. INSTEAD WE WOULD PREFER TO FIGHT FOR OUR FREEDOM THROUGH OTHER METHODS, LIKE THE IRISH, JEWS AND BASQUES."

20 DEC 91 - THE AWB THREATENS WAR IF DECISIONS TAKEN AT CODESA ARE ENFORCED, SAYING, "ANY ATTEMPT BY CODESA TO ENFORCE ITS ILLEGIMATE DISCUSSIONS OR ACTIONS WILL BE CONSIDERED BY THE AWB AS AN ACT OF WAR AND WILL BE TREATED AS SUCH." AT THE SAME TIME, HNP LEADER JAAP MARAIS SAYS RIGHT WING ORGANIZATIONS APPEAR POISED TO FORM A UNITED FRONT TO FIGHT THE CODESA DECISIONS.

-20 DEC 91 - THE LICHTENBURG TECHNICAL COLLEGE, WHICH RECENTLY ADMITTED ITS FIRST BLACK STUDENTS, IS DAMAGED BY THREE EXPLOSIONS. THE BOERE REPUBLICAN ARMY CLAIMS RESPONSIBILITY.

20 DEC 91 - A LARGE BOMB DAMAGES THE MAGISTRATE'S COURT IN THE EASTERN TRANSVAAL TOWN OF SABIE. THE BLAST BLEW A HOLE IN THE ROOF AND SHATTERED DOORS AND WINDOWS.

21 DEC 91 - A BLACK BEER HALL IN THE SMALL FARMING TOWN OF KOSTER IS DAMAGED BY AN EARLY MORNING EXPLOSION.

23 DEC 91 - ACCORDING TO NEWSPAPER REPORTS, POLICE INTELLIGENCE IS AWARE OF A RIGHT WING HIT LIST CONTAINING THE NAMES OF PROMINENT POLITICAL FIGURES, INCLUDING STATE PRESIDENT DE KLERK AND ANC PRESIDENT NELSON MANDELA. A POLICE SOURCE SAID ON 22 DEC THAT, "FOLLOWING THE BOMBING INCIDENTS IN THE WESTERN TRANSVAAL OVER THE PAST SIX DAYS, WE FEAR THAT RIGHT WING CELLS, SIMILAR TO THOSE UNCOVERED LAST YEAR, HAVE GONE INTO OPERATION WITH THE AIM NOT ONLY OF CARRYING OUT ACTS OF SABOTAGE. WE ARE AWARE OF A HIT LIST WHICH IS IN CIRCULATION CONTAINING NAMES OF GOVERNMENT LEADERS AND LEADERS ON THE LEFT OF THE POLITICAL SPECTRUM. WE FEAR THERE WILL BE ATTEMPTS TO EXECUTE THESE PLANS. OUR INFORMATION IS THAT SOME ELEMENTS ON THE RIGHT HAVE FORMED A NUMBER OF VERY SMALL CELLS. BECAUSE THEY ARE VERY SMALL, THEY ARE EXCEEDINGLY DIFFICULT TO UNCOVER."

-29 DEC 91 - NEWSPAPER REPORTS ALLEGE THE AWB IS TRAINING A UNIT FOR GUERRILLA WARFARE AT A SECRET BASE ON THE

LESOTHO BORDER. THE "YSTERGAR DE" (IRON GUARD) INCLUDES FORMER SADF RECCES, FOREIGN RIGHT WING SYMPATHISERS AND EX-MEMBERS OF THE SWATF SPECIAL FORCES. LED BY LEON ((VAN DER MERWE)), MEMBERS OF THE YSTERGARDE TRAIN FOR A WEEK AT A TIME. THEY WEAR NAVY BLUE BATTLE FATIGUES WITH AWB FLASHES ON THE SLEEVES, AND BALACLAVAS. TRAINING RANGES FROM MARKSMANSHIP TO MARTIAL ARTS, BUSH WARFARE, USE OF EXPLOSIVES AND HOSTAGE RESCUE. VAN DER MERWE SAID TRAINING WAS PROVIDED BY MILITARY EXPERTS FROM HOLLAND AND IRELAND, BUT DENIED AN IRA CONNECTION. VAN DER MERWE SAYS, "WE ARE READY TO FIGHT AND DIE FOR OUR FATHERLAND. SOON OTHERS WILL BE REQUIRED TO RISK THEIR LIVES, THEIR FAMILIES, THEIR FARMS AND THEIR JOBS TO JOIN THE STRUGGLE. THIS IS NOT A RACIAL BATTLE, BUT AND IDEOLOGICAL ONE. WHEN THE GOVERNMENT TRIES TO IMPLEMENT CODESA, WE WILL BE READY." LAW AND ORDER SPOKESMAN CAPT CRAIG ((KOETZE)) SAID THE SAP WERE AWARE OF THE YSTERGARDE AND WERE MONITORING THEIR MOVEMENTS. HE SAID THERE WERE NO LONGER ANY BANNED ORGANIZATIONS OR LAWS BARRING DRILLS AND MILITARY EXERCISES.

-29 DEC 91 - A LETTER FROM THE BOER REPUBLICAN ARMY IS REPORTED IN WHICH THE ORGANIZATION WARNED "BOER PATRIOTS" NOT TO LAUNCH ATTACKS WHICH RESULTED IN LOSS OF LIFE. HOWEVER, DESPITE CLAIMING THAT THEIR ENEMY IS "NOT BLACKS, BUT THOSE WHO WANT TO DESTROY THE BOER NATION", THE BRA IDENTIFIED ANC PRESIDENT MANDELA, CHAIRMAN TAMBO AND SA COMMUNIST PARTY LEADER HANI AS TARGETS FOR TERROR. THE BRA URGED ALL WHO SUPPORT A BOER HOMELAND TO ORGANIZE INTO CELLS OF TWO OR THREE MEMBERS, AND TO IDENTIFY TARGETS AT WILL. "WE SHOULD STEAL THE IDEALS OF MAO AND ADOPT THE TACTICS OF THE ZANLA FIGHTERS IN RHODESIA, USING ATTACKS ON MULTIRACIAL SCHOOLS AND CHURCHES, COURTS AND GOVERNMENT OFFICES TO INSTILL FEAR IN THE POPULATION."

-1 JAN 92 - SIX EXPLOSIONS CAUSE R2 MILLION DAMAGE TO THE MULTIRACIAL LOWVELD HIGH SCHOOL IN THE EASTERN TRANSVAAL TOWN OF NELSPRUIT.

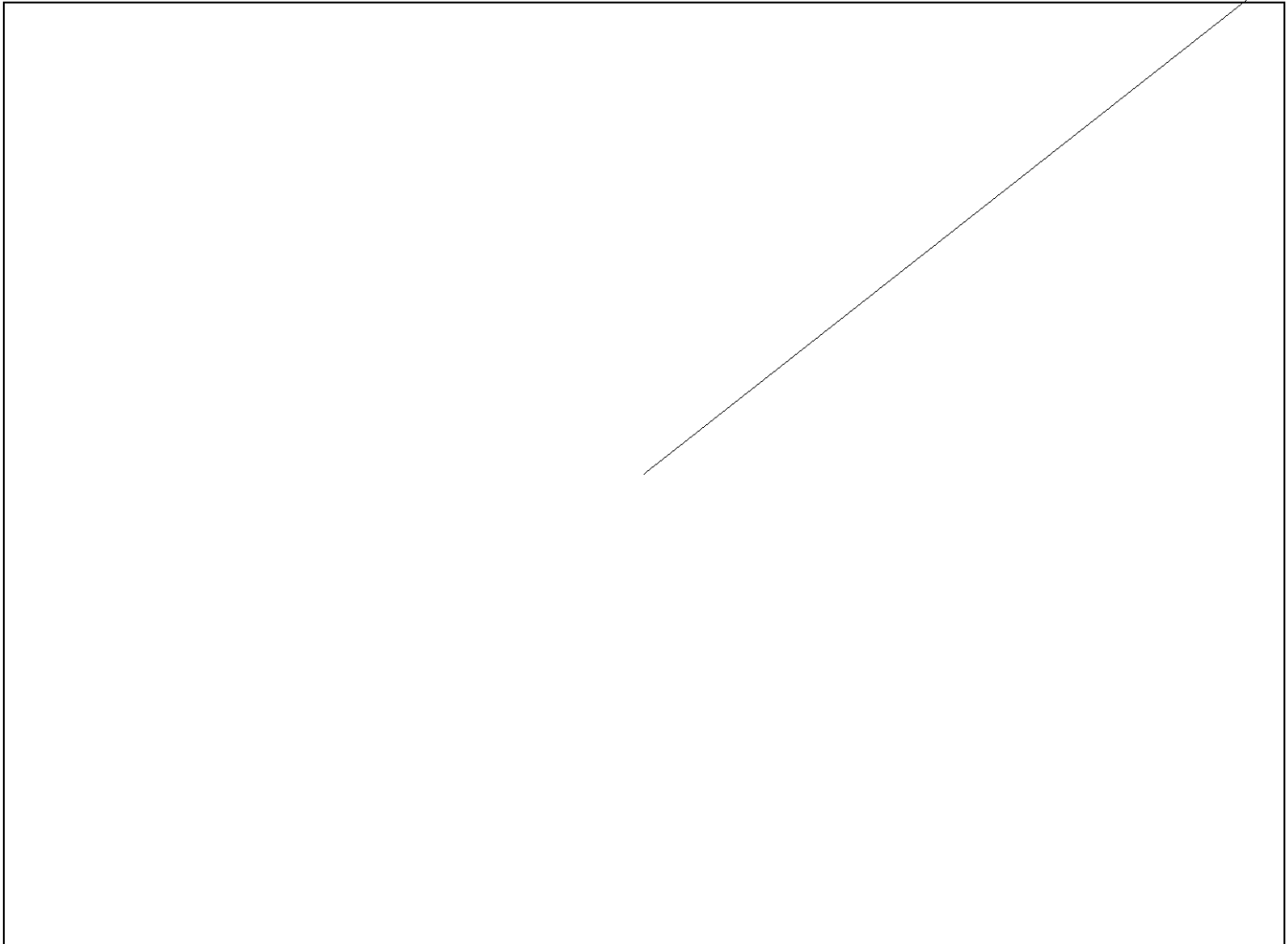
