<b>DAVID</b> ((HICKS)) ON SATURDAY 09DEC06. THE BASIS FOR THE PROTEST WILL
BE THE FOLLOWING ITEMS: A CALL FOR THE RELEASE OF ((HICKS)); FIVE
YEARS OF IMPRISONMENT IS TOO LONG; CLOSE THE DETENTION FACILITY AT
GUANTANAMO BAY, CUBA; AND STOPPING THE WAR ON CIVIL LIBERTIES.

PLANNING THE FOLLOWING PROTEST ACTIVITIES IN THE FOLLOWING LOCATIONS: 1) ADELAIDE, SA AT 11:00 AT VICTORIA SQUARE; 2) BRISBANE, QLD AT 14:00 AT QUEENS PARK; 3)MELBOURNE, VIC AT 14:00 AT FEDERATION SQUARE; 4) PERTH, WA AT 12:00 AT PERTH CULTURAL CENTRE; 5) SYDNEY, NSW AT 12:00 AT SYDNEY TOWN HALL. THE SYDNEY GROUP PLANS ON MARCHING TO MARTIN PLACE IN THE CENTRAL BUSINESS DISTRICT AND PROTEST NEAR THE U.S. CONSULATE AT 19-29 MARTIN PLACE IN THE MLC CENTRE.

3. (U) STOP THE WAR COALITION IS A SELF-PROCLAIMED ANTI-WAR ON TERRORISM IMG AND OPPOSES THE CURRENT ADMINISTRATIONS OF AUSTRALIA, THE UNITED STATES, AND ENGLAND. THE GROUP ALSO OPPOSES THE "BRUTAL OCCUPATION OF PALESTINE. FAIR GO FOR DAVID IS A GROUP CALLING FOR THE RELEASE OF THE AUSTRALIAN CITIZEN, **DAVID** ((**HICKS**)), CURRENTLY DETAINED AT GUANTANAMO BAY, CUBA. THERE NO INDICATIONS OF OTHER GROUPS, PARTICULARLY WITH A HISTORY OF VIOLENCE OR DISRUPTION, SCHEDULED TO PARTICIPATE.
