4. (U) TEGUCIGALPA, HONDURAS -- DURING THE FIRST SIX MONTHS OF THIS YEAR, A TOTAL OF 14 SMALL AIRPLANES, MOST WITH VENEZUELAN REGISTRATION, ENTERED THE COUNTRY.

SOME OF THEM WERE INCINERATED AFTER THOUSANDS OF KILOGRAMS OF COCAINE OR -- ACCORDING TO SUSPICIONS RAISED BY INVESTIGATIONS -- PACKAGES OF DOLLARS WERE REMOVED FROM THEM.

FOLLOWING THE EVENTS OF 28 JUNE, WHEN PRESIDENT MANUEL ZELAYA WAS

DEPOSED BY THE NATIONAL CONGRESS AND EXPELLED TO COSTA RICA, NOT A SINGLE SMALL AIRPLANE CARRYING DRUGS OR DOLLARS HAS ENTERED THE COUNTRY.

SOME LOCAL POLITICIANS, INTERNATIONAL ANALYSTS, EVEN U.S. POLITICIANS HAVE SUGGESTED THAT THERE IS A RELATIONSHIP BETWEEN DRUG LORDS AND OFFICIALS FROM THE PREVIOUS HONDURAN ADMINISTRATION. A U.S. CONGRESSMAN HAS EVEN ASKED HIS PRESIDENT TO HAVE THE INVESTIGATIVE BODIES THE ISSUE OF DRUG TRAFFICKING NETWORKS IN HONDURAS AND POSSIBLE TIES TO LOCAL POLITICIANS.

--ON THE PATH TO A NARCO STATE.

NATIONAL HUMAN RIGHTS COMMISSIONER RAMON CUSTODIO, ONE OF THE BEST INFORMED AUTHORITIES IN THE COUNTRY, FROM THE BEGINNING OF 2008 HAD BEEN WARNING OF THE DANGERS OF HONDURAS BECOMING A --NARCO STATE-- DUE TO THE FAST PACE AT WHICH THIS ACTIVITY HAD INCREASED IN THE COUNTRY OVER THE PAST THREE YEARS. MOREOVER, ON 07 JUNE 2008, CUSTODIO WARNED THAT THE REFORM OF THE POLICE ORGANIC LAW WOULD CONSOLIDATE THE --NARCO STATE--, BECAUSE THE LAW GIVES FULL POWERS TO

THE GENERAL POLICE DIRECTORS, AND IN THAT CASE (QUOTE) THIS COUNTRY MUST PREPARE TO SEE WHAT IS GOING TO HAPPEN, (END QUOTE) HE SAID.

CUSTODIO ASKED FORMER PRESIDENT ZELAYA TO CONDUCT A PURGE OF THE POLICE, BECAUSE WITH THIS LAW, THERE ARE POLICEMEN WHO HAVE TIES TO THREE CARTELS.

TIME IS GRADUALLY PROVING THAT CUSTODIO WAS RIGHT. PROOF OF THIS IS THAT ON 11 JULY THE POLICE CAPTURED 10 POLICEMEN IN LA MOSQUITIA, AMONG THEM TWO CHIEF OF THE INVESTIGATIVE POLICE, WITH 142 KG OF COCAINE. ACCORDING TO THE ANTI-NARCOTICS AUTHORITIES, THEY WERE SENT BY ONE OF THE POLICE DIRECTORS.

IN ONE OF HIS REPORTS, THE COMMISSIONER INSISTED THAT THE DRUGS PASS THROUGH HONDURAS WITHOUT A TRACE. THE REDUCTION OF SEIZURES DOES NOT MEAN THAT THE DRUGS NO LONGER PASS THROUGH HONDURAN TERRITORY; (QUOTE) ON THE CONTRARY, THE DRUGS PASS THROUGH WITHOUT A TRACE, BUT THEY LEAVE POCKETS FULL. BETWEEN 28 JANUARY AND 15 JUNE ALONE, THE DIRECTORATE FOR THE STRUGGLE AGAINST DRUG TRAFFICKING (DLCN) REPORTED THAT 14 --NARCO AIRPLANES -- LANDED IN THE COUNTRY, MOST OF THEM WITH VENEZUELAN REGISTRATIONS.

THE TRANSIT OF THESE AIRCRAFT LOADED WITH DRUGS WAS GRADUALLY INCREASING AS THE DEPOSED PRESIDENT FOCUSED HIS EFFORTS ON CONDUCTING A POLL TO ABOLISH THE CONSTITUTION AND THUS BE ABLE TO SEEK REELECTION. IN JUNE ALONE, FIVE AIRCRAFT WERE NABBED. FROM FIVE OF THE 14 --NARCO AIRPLANES -- DISCOVERED THIS YEAR, THE DLCN SEIZED 3,988 KG OF COCAINE. THE REMAINING AIRPLANES WERE FOUND EMPTY AND SOME WERE COMPLETELY INCINERATED.

THE SMALL AIRPLANES HAD BEEN LANDING ON THE COUNTRY'S ATLANTIC COAST IN ATLANTIDA, COLON, GRACIAS A DIOS, AND ISLAS DE LA BAHIA DEPARTMENTS.

OTHER SMALL AIRPLANES ALSO LANDED IN OLANCHO DEPARTMENT. THEY WOULD LAND ON CLANDESTINE LANDING STRIPS OR ON HIGHWAYS, FOR WHICH THEIR ***** START OF SECTION 2 *****

CONTACTS IN HONDURAS PLACED PORTABLE ILLUMINATION TO GUIDE THE PILOTS.

SOURCES CONSULTED BY EL HERALDO REVEALED THAT ONE OF THE AREAS WHERE THE DRUG TRAFFICKERS HAVE GREATER CONTROL IS GRACIAS A DIOS DEPARTMENT, WHERE IT HAS BEEN PRACTICALLY IMPOSSIBLE TO FIGHT AGAINST THIS SCOURGE.

THE DRUG TRAFFICKERS WOULD THROW THE DRUGS FROM THE AIR, AND BELOW THEY WOULD BE COLLECTED BY THEIR CONTACTS WHO IMMEDIATELY HID THEM. THIS WOULD BE FOLLOWED BY AN ENTIRE PROCESS OF INTERNAL TRANSPORTATION OF THE DRUGS AS THEY MADE THEIR WAY TO THE UNITED STATES.

THE HANDS OF REGIONAL DRUG LORDS OR THE GENERAL POPULATION. THIS SITUATION COULD CAUSE A CONFLICT IN THE AREA, WHAT WITH FIGHTS TO CLAIM THE ILLEGAL PRODUCTS. THE PROBLEM IS ALSO THAT THESE GANGS HAVE BETTER LOGISTICS THAN THE REGIONAL AUTHORITIES. THE SITUATION IS BEING EXAMINED.

THE INVESTIGATIVE BODIES ARE SUSPICIOUS THAT OVER THE PAST FEW DAYS, FOLLOWING ZELAYA'S EXPULSION, NO OTHER AIRCRAFT HAVE BEEN NABBED IN HONDURAN TERRITORY. REGARDING THIS ISSUE, DLN DIRECTOR ARISTIDES GONZALEZ SAID-- (QUOTE) I DO NOT WANT TO MENTION THAT BECAUSE IT WOULD BE HASTY ON MY PART. HOWEVER, THIS IS WHAT WE HAVE OBSERVED, THERE HAVE NOT BEEN MANY FLIGHTS. WE ARE GOING TO EXAMINE THIS AND REACH CONCLUSIONS. (END QUOTE)

RECENTLY, FORMER HONDURAN FOREIGN MINISTER ENRIQUE ORTEZ COLINDRES HINTED PUBLICLY THAT THERE WAS EVIDENCE THAT THE ZELAYA ADMINISTRATION WAS INVOLVED IN DRUG TRAFFICKING. MEANWHILE, TELEMUNDO NETWORK JOURNALIST PEDRO CEVCEC SAID PUBLICLY THAT A VERY TRUSTWORTHY SOURCE TOLD HIM THAT THERE WERE INDIVIDUALS IN THE ZELAYA ADMINISTRATION WHO HAD TIES TO COLOMBIAN AND VENEZUELAN DRUG

IN ONE OF HIS REPORTS CEVCEC SAID-- (QUOTE) THERE ARE INDIVIDUALS WHO HAVE LINKED HECTOR ZELAYA, SON OF DEPOSED HONDURAN PRESIDENT MANUEL ZELAYA, WITH DRUG TRAFFICKING GANGS. (END QUOTE) HE ADDED -- (QUOTE) ONE INVESTIGATION HAS ESTABLISHED THAT THERE MIGHT BE TIES BETWEEN INDIVIDUALS IN ZELAYA'S CABINET AND DRUG TRAFFICKING GROUPS. (END QUOTE)

THE FIGURES -- 4,000.

THE LAST SMALL AIRCRAFT THAT LANDED AND WAS FOUND INCINERATED MIGHT HAVE BROUGHT APPROXIMATELY 4,000 KG OF COCAINE INTO THE COUNTRY.

CHRONOLOGY -- 28 JANUARY 09 THE FIRST SMALL AIRPLANE WITH 1,500 KG OF COCAINE ENTERED THE COUNTRY.

12 JUNE 09 SMALL AIRPLANE DROPS 17 PACKAGES OF COCAINE INTO THE LA MASICA COMMUNITY.
