15. OUTLAWED MARXIST-LENINIST GUERRILLAS CLAIMED RESPONSIBILITY FOR SERIOUSLY WOUNDING TWO NAVY GUARDS ON DUTY AT BERTSSO (34528-5753W), ARGENTINA. ENRIQUE CASALDO, AN ABLE SEAMAN AND HORACIO PERALTA, A WOODCOMMISSIONED OFFICER, WERE FIRED AT POINT-BLANK RANGE WITH POWERFUL POLICE ISSUE ITAKA-AUTOMATIC-RIFLES. THE ASSAILANTS, A YOUNG MAN AND WOMAN, ESCAPED BY CAR. THIS UNUSUAL ATTACK APPEARS TO FOLLOW THE PATTERN OF "PROVING" TESTS CARRIED OUT BY URBAN GUERRILLAS WITH NEW RECRUITS. THE VICTIMS REMAIN IN SERIOUS OR CRITICAL CONDITION.
