ENBARRASSHENT TO HOST GOVERNMENT PARA 22-4, 16. (U) THIS IR SUPPLEMENTS (b)(3) 10 USC 424 WHICH COMDENTS ON DISCUSSIONS BETWEEN VADM GORDON SCHULLER, OSD-ISA, AND VARIOUS ARGENTINE OFFICERS. 22. (C/HOFORN) DETAILS: VADM SCHULLER WAS SCHEDULED TO MEET WITH THE ARGENTINE AIR FORCE SECRETARY GENERAL, BRIGADJER BASILIO LAMI DOZO, ON THE MORNING OF 790223. SINCE LAHI DOZO WAS ON LEAVE, THE ADMIRAL WAS RECEIVED BY COMODORO COTELO OF THE GENERAL SECRETARIAT. AFTER FIVE MINUTES OF EXCHANGING PLEASANTRIES, THE ADMIRAL WAS INFORMED THAT THE ARGENTINE AIR FORCE CHIEF OF STAFF, BRIGADIER MAYOR ROBERTO TEMPORINI, WOULD LIKE TO SEE HIM IN HIS OFFICE. THE MEETING WITH BRIG. TEMPORINI DECIDED TO ELEVATE THE ADMIRAL'S AIR FORCE VISIT TO THE CHIEF OF STAFF LEVEL AND, TWO, THAT HE PREDICTED SUCH A SIGNIFICANT IMPROVEMENT IN THE INTERNAL SITUATION IN THE NEXT FEW MONTHS. IN ADDITION, THESE FACTORS REINFORCE THE OFTEN REPORTED OBSERVATION THAT THE ARGENTINE AIR FORCE IS LINKED STRONGLY TO THE U.S. AND SINCERELY WANTS TO RENEW ITS TRADITIONALLY STRONG BONDS.
