THIS CAMPAIGN BEGAN ON SATURDAY NIGHT, FEB 8 BUT DID NOT COME OUT IN PRESS UNTIL TUES, 11 FEB. 2. SECURITY FORCES ARE MOUNTING UPN AGAINST TERRORISTS IN NW ARGENTINA (TUCUMAN PROVINCE). MAN IN STREET AWARE THAT FEDERAL POLICE AND ARMY TROOPS ARE MOVING INTO AREA. MORE ALARMING IS INFO BEING ACCEPTED BY ARMY, SPECIFICALLY: A. SOURCES SAY TERRORISTS HAVE 600-1000 PEOPLE IN TUCUMAN AREA, NUMBER OF COMBATANTS NOR FIRM AND MAY BE ON HIGH SIDE BUT POSSIBLY 4-600.
