AFTER DOMINGUEZ WILL BE BG ISIDRO BONIFACIO ((CACERES)) (CAVALRY) UNLESS HE STUMBLES. IN THAT CASE, BG MARTIN FELIX ((BONNET)), BG OSVALDO ((CORDOBA)) OR BGMACHINANDIARENA CULD GET ONE CALL. CACERES WILL BE FOLLOWED BY BG OSCAR OSVALDO ((SALOMON))

(INFANTRY) OR POSSIBLY BG EUNGENIO ALFREDO ((DALTON)), OR LESS LIKELY BG HORACIO GUILLERMO ((CANESTRO)). FOLLOWING SALOMON OR DALTON, WILL BE COL ENRIQUE BENITO ANTONIO ((LAURENTI)) (ARTILLERY) WITH EIGHT OTHER COLONELS HAVING A CHANCE. ((TABBIA)), CARLOS MARIA ((ZABALA)), LUIS ALBERTO ((CLOUX)) AND AN BAL ((LAINO)).
