SUMMARY: ~~(C/NOFORN)~~ THIS REPORT DESCRIBES PRESS COVERAGE WHICH LOCATES THE ARGENTINE NAVY FLEET IN THE MAR DEL PLATA AREA--A LOCATION NOT IN KEEPING WITH THE MOBILIZATION AND POSITIONING OF OTHER COMBAT FORCES IN THE BEAGLE CHANNEL DISPUTE. MILITARY TRAINING OF CORRESPONDENTS AND EDITING OF PRESS COVERAGE IS DESCRIBED AS THE BASIS FOR POSSIBLE COVER AND DECEPTION TACTIC. AT LEAST PART OF THE ARGENTINE FLEET IS PROBABLY SOUTH OF MAR DEL PLATA, PERHAPS AS FAR SOUTH AS GOLFO NUEVO.

DETAILS: 1. (U) AFTERNOON PRESS ON 781211 AND MORNING COVERAGE ON 781212 CONTAINED ARTICLES HEADED "THE IMPORTANCE OF OUR (ARGENTINE) NAVY AND NAVAL AIR POWER, BYLINED ABOARD THE CARRIER "25 DE MAYO" AND WRITTEN BY EMILIO IBARRA, THE 781212 "LA NACION" DESCRIBED TRAINING EXERCISES IN PROGRESS NEAR MAR DEL PLATA (b)(3):10 USC 424 UNDER THE COMMAND OF RADM BARBUZZI, CHIEF OF THE NAVAL SURFACE OPERATING FORCES. THE ARTICLE DESCRIBED THE FLEET EXERCISE INCLUDING ACTIVITIES OF CRUISERS, DESTROYERS, FRIGATES, CORVETTES AND SUBMARINES, ALONG WITH AIR OPERATIONS BY CARRIER BASED JET AND ASW PATROLS.
