(U) THE DAY-LONG FESTIVITIES WERE HOSTED BY THE EIGHTH INFANTRY BRIGADE, HEADQUARTERED IN MENDOZA, AND WERE ATTENDED BY SEVERAL THOUSAND HIGH RANKING MILITARY AND CIVILIAN DIGNITARIES, RETIRED MILITARY OFFICERS, ACTIVE DUTY INFANTRY OFFICERS, INFANTRY UNIT REPRESENTATIVES, AND FAMILIES/FRIENDS FROM ALL OVER ARGENTINA. PRESIDING OVER THE EVENTS WERE GENERALS **MARTIN ANTONIO ((BALZA))**, THE ARMY CHIEF OF STAFF, MARIO CANDIDO ((DIAZ)), THE CHIEF OF THE ARGENTINE JOINT STAFF, AND THE GOVERNOR OF THE PROVINCE OF MENDOZA. THE ENTIRE CELEBRATION WAS COVERED EXTENSIVELY BY THE ARGENTINE MEDIA.
