ITEM FOUR: ARGENTINA (AS OF 1400 EOT 24 MAR 76) (8/NFD/CO/WNSISMI) GOVERNMENT CONDUCTS ANTITERRORIST SHEEP. VIOLENCE BY LEPTIST AND RIGHTIST ELEMENTS HAS REACHED THE HIGHEST THERE HAVE LEVEL SINCE MAS PERON BECAME PRESIDENT IN JULY 1974. BEEN BOME 25 KILLINGS IN THE LAST FEW DAYS ALONE. IN A SWEEP THROUGH THO KEY PROVINCES, POLICE HAVE ARRESTED MORE THAN 188 PERSONS SINCE 29 MARCH, WHEN AN ALLEGED PLOT BY THE PEOPLE'S REVOLUTIONARY ARMY (ERF) TO CRIPPLE THE COUNTRY IS INDUSTRY HAS REVPALED. THE ERP HAD INTENDED TO ACHIEVE A SMUTGOWN BY LABORERS OF KEY INDUSTRIES MORTHWEST OF BURNOS ATRES. WITH THE ARRESTS, THE POLICE HAVE SCORED A VICTORY AGAINST THE ERP, GREATLY REDUCING ITS CHANCES FOR AN ECONOMICALLY ORIENTED OFFENSIVE IN THE AREA. HOWEVER, BECAUSE OF THE POLICE ACTION, HORKERS HAVE OCCUPIED SEVERAL FACTORIES TO PROTEST THE DETENTION OF LEFT-WING UNION LEADERS. THIS HAS INCREASED THE POTENTIAL FOR FURTHER VIOLENCE.

2. (8/NFD/CD/HNSISHI) POLITICAL INTRIBUE ALSO CONTINUES, AS ELEMENTS IN AND OUT OF THE PERDNIST MOVEMENT VIE FOR A GREATER ROLE IN THE GOVERNMENT WHICH HAS BEEN WEAKENED BY POWER STRUGGLES SINCE THE DEATH OF JUAN PERDN. THE LATEST TENSION IS APPARENTLY CAUSED BY KEY LABOR LEADERS WANTING MORE INFLUENCE IN THE ADMINISTRION. LAST WEEK'S EMERGENCY CABINET MEETING, CALLED TO CONSIDER THE THREAT AGAINST THE INDUSTRIES, WAS PROBABLY A DEVICE TO HALT THE INFLUENTIAL LEADERSHIP OF THE PERONIST-CONTROLLED LABOR MOVE-MENT FROM PLOTTING AGAINST MRS PERONIS KEY ADVISOR, LOPEZ REGA, HHO IS ALSO THE SOCIAL WELFARE MINISTER. THE MEETING, HOWEVER. ENDED INCONCLUSIVELY POSSIBLY SECAUSE OF OPPOSITION TO LOPEZ

REGA FROM SOME CABINET MEMBERS.

3. (S/MED/CD/MASSMI) MOST KEY POLITICAL ELEMENTS ARE APPARENTLY NOW OPPOSED TO THE SOCIAL MELPARE MINISTER. MITHIN LABOR CIRCLES AND IN CONGRESS, THE OPPOSITION SEEMS TO BE CRYSTALIZED, AND CONTINGENCY PLANNING FOR A CONSTITUTIONALLY ACCEPTABLE REPLACEMENT FOR MRS PERON IS UNDER MAY, SHOULD SHE REFUSE TO OUST HIM. THIS PLANNING REPORTEDLY INVOLVES THE MILITARY BUT ONLY IN AN "EXPLORATORY" FASHION. ALTHOUGH SOME DISSATISFACTION, PRIMARILY AGAINST LOPEZ REGA, EXISTS IN THE ARMED FORCES AND SOME
