

ARGENTINA: HUMAN RIGHTS ACTIVIST'S HOME BOMBED (U)

(U) A news agency reported that on 4 August, a bomb exploded outside the home of a human rights activist in Cordoba, Argentina. Rodolfo Barraco Aquirre, a member of the local chapter of the National Commission on the Disappearance of Persons, was in his home with his family when the blast occurred at 0430 hours. There were no injuries but the blast caused heavy structural damage. Barraco Aquirre reported that the bombing followed a series of telephoned death threats against him and his family in recent months.
