- 2. (U) THE CIRCULO MILITAR DEL EJERCITO (CM) IS A SOCIAL ORGANIZATION OF ACTIVE AND RETIRED ARMY OFFICERS. IT OFFERS VENUES FOR SOCIAL FUNCTIONS AND SPORTS ACTIVITIES, AND MOST OFFICERS ARE MEMBERS. THE CM ALSO SERVES AS AN "UNOFFICIAL" PLATFORM FOR THE ARMY ON ISSUES SUCH AS PAY, HEALTH CARE, ETC. THE LARGE NUMBER OF RETIRED MEMBERS GIVES THE CM A DECIDEDLY CONSERVATIVE INCLINATION.
- 3. (U) NO SOONER HAD GENERAL BALZA RETIRED, THEN THE CIRCULO MILITAR LEADERSHIP VOTED TO SUSPEND HIM INDEFINITELY FROM THE ORGANIZATION. ALTHOUGH NOT THE MOST DRASTIC OPTION AT THEIR DISPOSAL (WHICH WOULD HAVE BEEN "EXPULSION"). IT WAS NEVERTHELESS A PERMANENT SANCTION. THIS SHOULD OCCUR SOON. IN VINTAGE BALZA STYLE, THE ENTIRE EPISODE HAS BEEN PLAYED OUT IN THE MEDIA SPOTLIGHT.
