PAGE 3 31307 SITUATION IS VERY TICKLISH SINCE THE ARMED FORCES CAN NOT AFFORD TO DESTROY THE MORALE OF THE TROOPS WITH PUBLIC CONDEMNATIONS OF THE GUILTY. CONSEQUENTLY, MOST OF THE OFFENDERS ARE DEALT WITH INTERNALLY AND WITHOUT PUBLICITY. HE SEEMED PLEASED THAT NOT TOO (b)(3):10 USC MANY OFFICIALS WERE RESPONSIBLE FOR EXCESSES ALTHOUGH HE ADMITTED 101 THAT THERE WERE A NUMBER IN THE FEDERAL POLICE AND A FEW IN THE ARMY. TO EMPHASIZE THAT JUSTICE WAS BEING CARRIED OUT, HE TOLD THAT FOUR NCO'S WERE APPREHENDED LAST WEEK AND PUT IN JAIL. COMMENT: (C) THE SOURCE WAS VERY OPTIMISTIC IN HIS APPRAISAL OF THE SITUATION IN ARGENTINA. THERE IS NO DOUBT THAT THERE IS AN EFFORT UNDERWAY TO BRING THINGS UNDER CONTROL. WHETHER THE GOVERN-MENT WILL BE AS SUCCESSFUL AS THE SOURCE SUGGESTS, REMAINS TO BE SEEN. NEVERTHELESS, IT IS ENCOURAGING THAT THE MILITARY HAVE FINALLY COME TO GRIPS WITH A BASIC HUMAN RIGHTS PROBLEM AND ARE APPARENTLY TAKING POSITIVE STEPS TO REVERSE THE SITUATION.
