16. ~~(S/NF)~~ THIS REPORT PROVIDES AFTER-ACTION INFORMATION CONCERNING THE ARGENTINE ARMY 5TH CORPS'S EXPERIENCES DURING THE MOBILIZATION EXERCISES WHICH OCCURRED DURING 7810/7812 IN THE SOUTHERN PART OF ARGENTINA. ALSO REPORTED ARE EVENTS WHICH TOOK PLACE IN THE 3RD CORPS AREA OF OPERATIONS IN THE VICINITY OF BARILOCHE (b)(1);1.4 (c)

INFORMATION RECEIVED INDICATES THAT THE ARGENTINE ARMED FORCES WERE GIVEN THE ORDER TO ATTACK CHILE WITH H-HOUR SET FOR 2400 HOURS ON 781222. THE ORDER WAS REVOKED AT 1630 HRS THE SAME DAY AND THE LAST UNIT TO RECEIVE THE REVOCATION ORDER WAS INFORMED AT 2130 HOURS.

COMMENT: (SANDFORN) THIS REPORT IS OF INTEREST IN THAT IT GIVES INFORMATION INDICATING THAT THE ACTUAL ORDER TO ATTACK CHILE HAD BEEN ISSUED AT MID-DAY ON 791222 AND RESCINDED THAT AFTER-NOON WHEN WORD THAT THE POPE WOULD MEDIATE THE BEAGLE CHANNEL DISPUTE BECAME KNOWN. THIS REPORT ALSO PROVIDES INFORMATION INDICATING THAT THE ARGENTINE ARMY HAD A MAIN ATTACK PLANNED IN THE 3RD CORPS AREA TO BE LAUNCHED FROM ZAPALA WHICH HAD BECOME A MAJOR STAGING AND TROOP CONCENTRATION AREA. ALSO OF SIGNIFICANCE IS THE FACT THAT PUNTA ARENAS BECAME A PRINCIPLE OBJECTIVE FOR THE 5TH ARMY CORPS LOCATED IN THE SOUTHERN REGION OF ARGENTINA. THE FACT THAT ARMY ENGINEER UNITS AND PUMA HELICOPTERS WERE ASSIGNED TO SUPPORT 10,000 MARINES ON TIERRA DEL FUEGO IS ALSO OF INTEREST AND SHOWS A DEGREE OF INTER-SERVICE COOPERATION WHICH THE ARGENTINE FORCES HAVE NOT PREVIOUSLY PRACTICED.

THIS INFORMATION CONCERNING THE EVENTS OF DEC 1978, COULD AT A LATER DATE PROVE WORTHWHILE SHOULD THE BEAGLE CHANNEL SITUATION AGAIN BECOME A VOLATILE ISSUE.
