SOURCE DISCUSSED RECENT U.S. AMBASSADOR CASTRO'S VISIT WITH ARGENTINE FOREIGN MINISTER PASTOR, IN WHICH THE FORMER EXPRESSED CONCERN FOR JEHOVA'S WITNESSES IN ARGENTINA. ACCORDING TO SOURCE, AMBASSADOR CASTRO'S OVERTURE ON BEHALF OF THE LITTLE KNOWN RELIGIOUS SECT, ALONG WITH OTHER GROUPS' INITIATIVES, HAS HAD AN EFFECT ON THE GOA.

2. ~~(C/NOFORN)~~ SOURCE CITED AN INCREASING NUMBER OF LOW-RANKING NON-COMMISSIONED OFFICERS AND RECRUITS CLAIMING EXEMPTION FROM MILITARY SERVICE, ACCENTUATING DIFFICULTIES OF THE GOVERNMENT IN DEALING WITH THE JEHOVA'S WITNESSES. FOUR ARGAF NCO'S ARE NOW UNDER ARREST IN PARANA, AND ARE AWAITING TRIALS; IF FOUND GUILTY, THEY COULD FACE SENTENCES OF FOUR YEARS.

3. ~~(C/NOFORN)~~ ACCORDING TO SOURCE, GOA IS DEALING WITH THE MATTER BROUGHT UP BY AMBASSADOR CASTRO IN A SERIOUS AND RESPONSIBLE WAY. THE GOVERNMENT, HE ASSERTED, IS UNDERTAKING A STUDY TO DETERMINE HOW BEST TO RESOLVE THE PROBLEM-- AND MEET USG APPROVAL AS WELL. CURRENTLY BEING CONSIDERED IS THE ALTERNATIVE OF ALLOWING THE JEHOVA'S WITNESS MEMBERS SERVE TWO YEAR "CIVIL SERVICE" ENLISTMENT IN AREAS SUCH AS FORESTRY WITH THE NATIONAL PARK SERVICE, WITH YPF (YACI-MIENTOS PETROLIFEROS FISCALES, STATE OIL ENTITY) OR IN STATE MINES IN ISOLATED AREAS OF THE COUNTRY. THIS WOULD NOT ONLY ELIMINATE THE JAIL SENTENCES, BUT WOULD ALSO GIVE GOA FLEXIBILITY IN DEALING WITH THE PROBLEM OF PROVIDING MUCH-NEEDED LABOR IN REMOTE AREAS OF THE COUNTRY.
