(b)(1),1.4 (c) ARE UPSET AND FEEL THAT PRESIDENT FUJIMORI'S ADVISOR VLADIMIRO ((MONTESINOS)) TORRES HAS BEEN INSTRUMENTAL IN DECIDING MANY OF THE KEY ARMY ASSIGNMENTS. MONTESINOS GRADUATED FROM THE PERUVIAN MILITARY ACADEMY (ESCUELA MILITAR DE CHORRILLOS) AND WAS COMMISSIONED AS AN ARTILLERY OFFICER ON 1 JAN 1966. IN THE LATE 1970'S, MONTESINOS WAS CHARGED WITH ESPIONAGE AND SPENT SOME TIME IN JAIL.
