HE THEORIZED THAT THE GROUPS WHICH GAINED THE MOST FROM THE DISAPPEARANCES ARE THE SUBVERSIVE ELEMENTS. AND THEREFORE IT SHOULD NOT BE DISCOUNTED THAT THEY HAVE BOTH SOLA AND THE LAWYERS. SOURCE B THEN SAID THAT PERHAPS SOLA HAD CAUSED HIS OWN KIDNAPPING IN ORDER TO LATER RE-APPEAR, BLAME EITHER THE GOVERNMENT, OR DHE OF THE SUBVERSIVE GROUPS, AND REAP HUGE POLITICAL BENEFITS FOR THE FUTURE. SOURCE B'S COMMENT ABOUT THE ONLY THO FACTS IN THE SOLA CASE IS PROBABLY TRUE. FROM THAT POINT ON, ALL IS CONJECTURE, THE SIZE AND COMPLEXITY OF AN OPERATION THAT COULD SUCCESSFYLLY KIDNAP SOLA HOULD REQUIRE MORE RESOURCES THAN THE SUBVERSIVES HIGHT BE WILLING TO RISK FOR THIS TYPE OF ACTION. THERE HAS BEEN A NEW SET OF GUIDELINES ON COUNTER SUBVERSIVE OPERATIONS ISSUED TO THE SECURITY FORCES.
