16. SUMMARY: (U) THIS IR FORWARDS INFORMATION ON ARGENTINA'S PARTICIPATION IN UNITAS XVIII.

2. DETAILS: (C/NOFORN) SOURCES Sec. 3.3(b)(1) THERE ARE PROBLEMS BREWING ON THE UPCOMING UNITAS OPERATION. ONE SOURCE STATED THAT THE COUNTRIES OF URUGUAY, CHILE, ARGENTINA AND BRAZIL HAVE AGREED THAT IF ONE OF THESE COUNTRIES DECIDES NOT TO PARTICIPATE IN UNITAS XVIII, ALL THE REST WILL COLLECTIVELY CANCEL. IN ARGENTINA, THE ARMY, SUPPORTED BY THE AIR FORCE, FEELS THAT UNITAS IS MORE OF A POLITICAL EXERCISE AND IS AGAINST PARTICIPATION WHILE THE NAVY VIEWS IT AS STRICTLY MILITARY, I.E., A NAVY-TO-NAVY OPERATION. THE SUPREME POWER OF THE COUNTRY, THE JUNTA, COMPRISED OF THE THREE SERVICE CHIEFS WILL HAVE TO MAKE THE FINAL DECISION. THE DECISION SHOULD BE FORTHCOMING THIS WEEK. ONE SOURCE STATES THAT ADM MASSERA, THE NAVY CHIEF JUNTA MEMBER, WILL PROBABLY BE ABLE TO PREVAIL OVER THE OTHER MEMBERS IN SEEING THAT ARGENTINA PARTICIPATES IN UNITAS XVIII. HOWEVER, ANOTHER COUNTRY'S CANCELLATION WILL HAVE A BINDING EFFECT ON THIS COUNTRY. THE ARGENTINE NAVY STAFF FAVORS CONTINUING UNITAS OPERATIONS BUT STATE THAT THEY PREFER IT TO BE CONDUCTED EVERY TWO YEARS. PLANNING AND PREPARATION WILL CONTINUE FOR THIS YEAR'S UNITAS UNTIL A POLITICAL DECISION BY THE JUNTA INDICATES OTHERWISE. SOURCES HERE ARE VAGUE ON WHICH COUNTRY IS PUSHING FOR THE CANCELLATION. ONE SOURCE WAS ASKED IF IT WAS BRAZIL; HIS REPLY WAS NO. WHEN ASKED IF IT WAS ARGENTINA OR ONE OF THE OTHER COUNTRIES HE WAS VAGUE AND DID NOT REPLY. SOURCE ENDED, STATING THAT THE UNITAS BAND CAUSES CONSIDERABLE CONCERN SECURITY-WISE TO THE ARGENTINE MILITARY.

COMMENT: (C/NOFORN) WHETHER MASSERA CAN PREVAIL OVER THE OTHER TWO JUNTA MEMBERS ON HIS DECISION TO PARTICIPATE IN UNITAS IS QUESTIONABLE. HIS POWER OVER THE ARMY AND AIR FORCE IS NOT AS STRONG AS IT ONCE WAS IN THE INITIAL STAGES OF THE MILITARY TAKEOVER. VIDELA, WITH AGOSTI'S SUPPORT, VIEWING THE WHOLE OPERATION AS A POLITICAL ONE, MAY FORCE THE CANCELLATION OF UNITAS XVIII. THIS ATTITUDE UNDOUBTEDLY IS BASED ON THE US POSITION TOWARD ARGENTINA REGARDING HUMAN RIGHTS ISSUES AND MILITARY AID. THIS MSG HAS BEEN COORDINATED WITH EMBASSY.
