REPORTEDLY RESPONDS DIRECTLY TO THE ARMY COMMANDER ON POLITICAL/MILITARY AFFAIRS). IT IS REPORTED THAT HE COULD NOT WAIT FOR THE TERMINATION OF THE PRESTIGIOUS NATIONAL DEFENSE COLLEGE (SIMILAR TO NWC) AT THE END OF THE YEAR AND HAD ONE OF ITS MEMBERS PREMATURELY REASSIGNED TO HIS STAFF PRIOR TO GRADUATION.

2. (C/WHINTEL/NOTORN) SOURCE WAS ASKED WHO MIGHT LEAD A MILITARY GOVERNMENT SHOULD MRS PERGN BE OUSTED. HE STATED THAT THE MOST PROMISING CANDIDATE WAS MAJOR GENERAL (RETIRED) ALCIDES LOPEZ AUFRANC (LOPEZ AUFRANC RECENTLY APPEARD ON A TV TALK SHOW AND SPOKE OUT STRONGLY OF THE HILITARY'S RESPONSIBILITY TO MOVE IN THE EVENT THE GOVERNMENT FELL INTO CHAOS.) SOURCE STATED THAT A SECOND POSSIBILITY IS BG LUCIANU MENENDEZ, CURRENT III CORPS COMMANDER. GEN MENENDEZ HAS BEEN RESPONSIBLE FOR THE ARMY'S COIN OPERATION IN TUCUMAN, SINCE THE DEPARTURE OF BG DELIA LAST AUGUST. HE SUGGESTED AS A DARK HURSE CANDIDATE. BG ANTONIO BUSSI, COMMANDER OF THE X INFANTRY BRIGADE IN PALERMO. GEN BUSSI IS ON TAP TO COMMAND THE V INFANTRY BRIGADE IN TUCUMAN NEXT MONTH, BUSSI IS REGARDED AS AN INTELLIGENT AND COMPETENT OFFICER BY THE SOURCE BUT IS CONSIDERED A THIRD CHDICE BECAUSE OF HIS AGE (HE IS A VERY JUNIOR GENERAL OFFICER).

3. <u>(CAWNINTEL/HOFORN)</u> DF HIS CONCERN OVER THE PRESENT POLITICAL SITUATION. SOURCE, LIKE MANY MILITARY, HOPES THAT THE ELECTIONS IN 1976 WILL COME TO PASS, BUT DOUBTS THAT THE PERONISTS CAN SURVIVE UNTIL THAT TIME. HE COMPARES THE CURRENT REGIME TO A SINKING SHIP IN HEAVY SEAS WITHOUT A CAPTAIN OR CREW. HE DESCRIBES THE ADMINISTRATION, AS WELL AS THE CONGRESS AS A MOB OF UNPRINCIPLED, CORRUPT POLITICIANS WHO LACK A SENSE OF

4 COMMINTEL/NOFORM) COMMENT: NERVOUSNESS IS INDEED INCREASING AS MILITARY AND REPRESENTATIVES FROM OTHER SECTORS SPEAK OPENLY ABOUT THE POSSIBILITY OF A "GOLPE". UNTIL RECENTLY THE ARMED FORCES SEEMED FIRM IN THEIR RESOLVE TO LET THE POLITICIANS PLAY OUT THEIR HANDS. HOWEVER, CONTINUED ALLEGATIONS AND INVESTIGATIONS OF CORRUPTION IN THE PERGNIST GOVERNMENT ARE TAKING THEIR TOLL. THUS, DESPITE THE DECISION TAKEN AT THE DEC 5 MEETING NOT TO INTERVENE IMMEDIATELY, AS THE PATIENCE OF THE MILITARY GROWS SHORTER THE POSSIBILITY OF MILITARY INTERVENTION IN THE GOVERNMENT INCREASES. THIS MSG HAS BEEN COORD WITH EMBASSY.
