COMMENT: ~~(C)~~ MILITARY FACTORIES HAS DEFINITELY DECIDED TO REMODEL ITS MUNITIONS PRODUCTION FACILITIES AT ITS BELTRAN AND SAN FRANCISCO PLANTS.
