TEXT: 1. (C) ON 921202, THE U.S. EMBASSY RECEIVED A LETTER SIGNED BY 'CODEMA' AN ORGANIZATION COMPOSED OF ACTIVE DUTY AND RETIRED PERUVIAN MILITARY PERSONNEL FROM THE ARMY, NAVY AND AIR FORCE. IN THE LETTER, CODEMA AND COMACA (ANOTHER ORGANIZATION COMPRISED OF ARMY COLONELS TO CAPTAINS) PRAISE THE DIRECTORATE OF COUNTER-TERRORISM (DINCOTE) FOR ITS SUCCESSES AGAINST NARCOTERRORISM, SENDERO LUMINOSO AND THE M.R.T.A. CODEMA AGREES WITH THE FUNDAMENTAL ASPECTS OF PRESIDENT FUJIMORI'S GOVERNMENT, HOWEVER, THEY STATE THAT HIS SOCIAL ECONOMIC POLICIES NEED TO BE ADDRESSED AND CORRECTED FOR THE BENEFIT OF THE THE ORGANIZATIONS HOPE THAT THE PERUVIAN PEOPLE.
