Subject is very intelligent, and quick witted. He is somewhat autocratic in his military relationships, but not in his family relationships. He is able to communicate complex legal concepts in laymen's language.

He is basically apolitical, but in the Argentine domestic political spectrum would be considered a moderate right wing anti-peronist. In the international context, he is staunchly anti-communist. Sec. 3.3(b) (1);(b)(3);10 USC 424
except he feels the Carter administration is mistaken in the application of its human rights policies. He is a strong advocate of human rights as a concept, but feels strongly that the Argentine legal system is unable to respond to the challenge of subversive tactics. Therefore, extraordinary measures are justified to preserve the rights of the vast majority of the Argentine population. He is cordial but not friendly with members of the communist-bloc diplomatic missions, but he expresses this cordiality in a cold, formal manner. As the senior ARGAF legal expert he is the most likely person to become the new Minister of Justice when the incumbent is released from that position.

Subject has an excellent reputation as a military lawyer. He has been the senior active duty ARGAF lawyer for almost eight years. Sec. 3.3(b) (1) expect that he will be the next Minister of Justice. Among the rank and file of the ARGAF, he is considered to be tough and fair as a military judge. He has a reputation for being completely honest, and living totally on his ARGAF pay (few other ARGAF flag officers enjoy this reputation). He has an international reputation in legal matters dealing with international aviation. He would be an excellent Staff Judge Advocate in any air force.
