B. (C/NOPORN) AS FAR AS THE BEAGLE CHANNEL DISPUTE WITH CHILE GOES, (b)(1);(b)(3);10 USC 424;Sec. 1.4(c) THAT 781212 AND SHORTLY THEREAFTER WILL BE CRITICAL TO BOTH GOVERNMENTS. GOA CANNOT ACCEPT ANYMORE GOC DELAYS TO CHANNEL QUESTION WITH FORECAST BEING (HIS VIEWS) THAT A CONFLICT IS, FOR NOW, UNAVOIDABLE. IF GOA-GOC MEETING PROVES A FAILURE, UNSURMOUNTABLE PRESSURE TO GOA WILL BE FOR MILITARY ACTION AGAINST GOC.
