EITHER IN A MILITARY OR POLITICAL SENSE, WHEN ASKED HE THOUGHT THAT THE CONTROVERSY OVER COL. DAMASCOTS APPOINTMENT HOULD DIE DOWN, HE RESPONDED THAT IT WAS EAR FROM OVER. HE DID NOT BELIEVE THAT DAMASCO, HOULD LAST THE TWO MONTHS WHICH THE LAW ALLOWS HIM TO STAY IN AN ACTIVE STATUS, SINCE HE 18 IN A "NO-WIN" SITUATION. SOURCE POINTED-OUT THAT MANY POLITICAL AND LABOR LEADERS RESENT THAT A MILITARY MAN OCCUPIES THE MOST POWERFUL POLITICAL POST INTHE CABONET AND HE DOUBTS THAT THEY WILL GIVE HIM THE SUPPORT AND COOPERATION THAT HE NEEDS. HE WENT ON TO CONFIRM PREVIOUS REPORTS THAT THE AIR FURCE AND NAVY CINCOS DEEPLY RESENTED THAT THEY WERE NOT PREVIOUSLY CONSULTED ON THE DAMASCO APPOINTMENT AND THAT THE DIVISION IN THE ARMY IS REAL AND PROFOUND, WHEN PRESSED HOW SUCH AN APPOINTMENT COULD HAVE COME ABOUT, SOURCE TOLD OF THE CLOSE RELATIONSHIP WHICH DEVELOPED BETWEEN GENERAL PERON AND COM. DAMASCO. HE THEN REVEACED THAT PERON ADVISED HIS HIFE FROM HIS DEATH BED NEVER TO SIGN A DECREE WITHOUT FIRST CHECKING WITH "ESTE MUCHACHO" (THIS BOY) . REFERRING TO DAMASCO. SOURCE FELT THAT MRS. PERON, REMEMBERING THE GENERAL S ADVICE, AND HAVING LOST LOPEZ REGA, TURNED IN DESPERATION TO DAMASCO.
