EXPRESSED THAT THEY FULLY AGREED WITH GENERAL (R) JAIME ((SALINAS)) SEDO IN HIS STATEMENTS TO RETURN THE INSTITUTIONAL DIGNITY TO THE PERUVIAN ARMY, TO TAKE ACTION AGAINST THOSE OFFICERS INVOLVED IN CORRUPTION AND NARCOTRAFFICKING AND TO ELIMINATE FROM THE ARMY'S RANKS THOSE OFFICERS WHO HAVE BECOME POLITICALLY INVOLVED IN GOVERNMENT. NEVERTHELESS THESE SAME (b)(1),1.4 (c) WERE CAREFUL TO STATE THAT THEY DID NOT AGREE WITH SALINAS IN HIS EFFORTS TO RETURN PERU TO THE POLITICAL SITUATION THAT EXISTED BEFORE 5 APR 92.

2. ~~(S/NF)~~ IN GENERAL (b)(1),1.4 (c) ARE SUPPORTIVE OF FUJIMORI'S PROGRAMS TO PROFOUNDLY TRANSFORM PERUVIAN NATIONAL LIFE, OF HIS CONCERN FOR THE POOR AND FORGOTTEN PEOPLE OF PERU, AND OF FUJIMORI'S DECISION TO ENERGETICALLY FIGHT THE INTERNAL TERRORISM AND SUBVERSION.

3. ~~(S/NF)~~ ALTHOUGH THEY GENERALLY DO AGREE WITH PRESIDENT FUJIMORI AND FEEL THAT HE IS LEADING THE COUNTRY WELL, (b)(1),1.4 (c) ARE GREATLY UPSET WITH THE METHODS BEING USED BY THE GOVERNMENT IN UNCOVERING OFFICERS INVOLVED OR SUSPECTED OF BEING INVOLVED IN THE ATTEMPTED COUP, IN MANIPULATING THE EVIDENCE AGAINST THEM AND IN THE MANNER IN WHICH ARMY OFFICERS HAVE BEEN INTERRORGATED BY THE NATIONAL INTELLIGENCE SERVICE (SIN) OR DINCOTE. THEY FEEL THAT THESE ACTIONS ARE BEING DIRECTED BY THE PRESIDENTIAL ADVISOR, VLADIMIRO MONTESINOS. THEY FEEL THAT TOO MANY OF THE HIGHER

4. ~~(S/NF)~~ (b)(1),1.4 (c) HAVE ALSO STATED THAT MEMBERS OF THE SIN HAVE BEEN WORKING IN THAT NORTHERN REGION CONDUCTING INVESTIGATIONS ON POSSIBLE CONNECTIONS OR IMPLICATIONS OF OTHER ARMY OFFICERS WITH THE COUP PLOTTERS. THIS HAS MADE THE OFFICERS FEEL VERY UNCOMFORTABLE AND FURTHER CREATE DISENCHANTMENT WITH THE ARMY COMMAND FOR ALLOWING IT TO HAPPEN.
