MG ARENAS BELIEVES HE WILL SOON REPLACE THE CURRENT DIRECTOR OF ARMY INTELLIGENCE (DINTE), MAJOR GENERAL JUAN ((YANQUI)) CERVANTES. IN MID-MAY 97, MG ARENAS COMMENTED THAT HE HAD BEEN TOLD BY PERUVIAN ARMY COLONEL LUIS ((ABT)) TORRES, THE PERSONAL SECRETARY TO THE PERUVIAN ARMY COMMANDING GENERAL, NICOLAS DE BARI ((HERMOZA)) RIOS, TO PREPARE TO ASSUME THE DUTIES OF DIRECTOR OF DINTE.
