THE FAILED EFFORT TO MURDER THE TREASURY SECRETARY, APPARENTLY BY MONTONEROS, AND ONE HARDLINERS ANOTHER ARGUMENT TO USE AGAINST THE LEADERSHIP OF PRESIDENT VIDELA AND ARMY COMMANDER VEOLA. 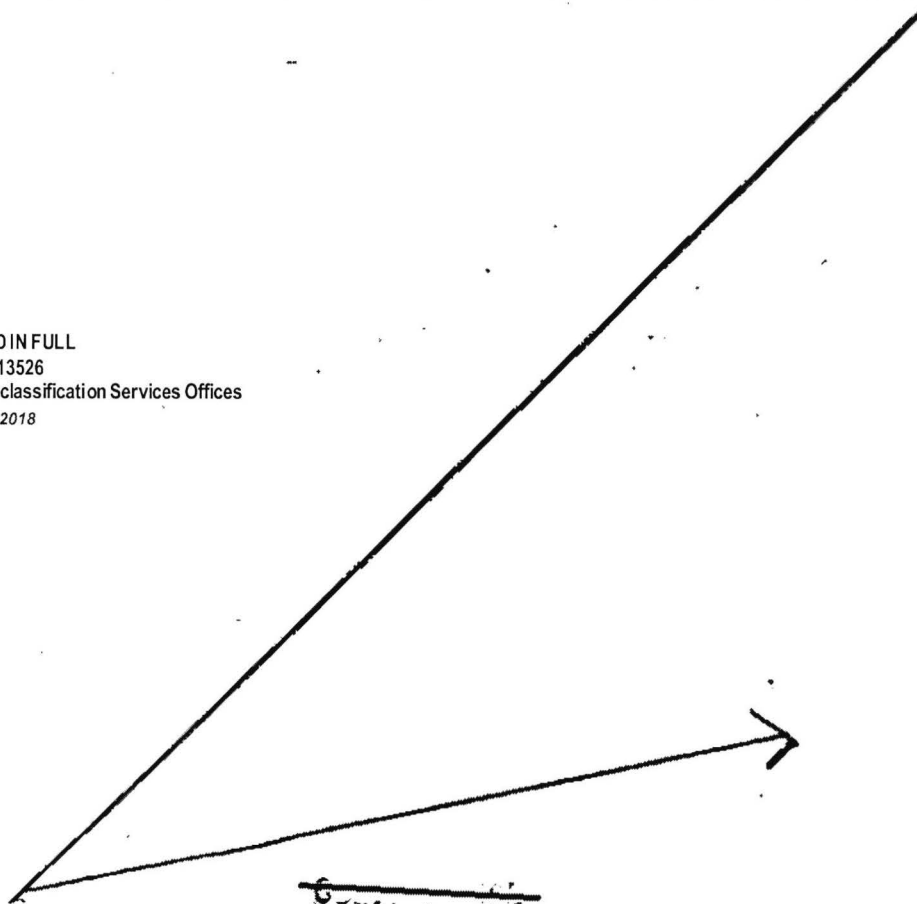

4. ~~(C)~~ MENENDEZ LETTER PUBLISHED: THE PRESS HAS
PUBLISHED A LETTER WRITTEN BY RETIRED GENERAL LUCIANO
BENJAMIN MENENDEZ WHO IS NOW SERVING A 90-DAY SENTENCE
FOR HIS FAILED COUP ATTEMPT IN SEPTEMBER. THE LETTER
WAS ADDRESSED BY MENENDEZ TO HIS MILITARY COLLEAGUES
TO EXPLAIN HIS MOTIVES AND OBJECTIVES IN SEEKING TO
OVERTHROW THE VIDELA REGIME.

MENENDEZ REPEATS HIS NOW FAMILIAR CHARGES THAT THE
VIDELA GOVERNMENT ~~WAS~~ BUCKLED TO FOREIGN PRESSURE ON
HUMAN RIGHTS (IAHRC, TIMERMAN AND CAMPORA) AND IN THE
BEAGLE CHANNEL DISPUTE WITH CHILE. IN ADDITION, HE SAYS
THAT INSTEAD OF BRINGING A NEW DAWN FOR ARGENTINA THE
GOVERNMENT IS PREPARING TO HAND OVER THE COUNTRY TO
"THE PARTY OF FRIENDS," THE SAME LEADERS THAT HE ALLEGES

WE UNDERSTAND FROM A VARIETY OF SOURCES THAT MENENDEZ
SENTIMENTS ARE SHARED BY MANY OFFICERS BELOW THE RANK

THESE MEN WERE NOT PREPARED TO BREAK RANKS AND FOLLOW
HIM IN SEPTEMBER AND THEY ARE LESS DISPOSED TO DO SO

CONTINUES TO GRIND THROUGH ITS PROMOTION LISTS,
LOOKING ULTIMATELY TO THE KEY CHANGE -- THE SUCCESSION

FOR HIS PART, VIOLA CONTINUES TO VOICE PUBLIC CON-
FIDENCE THAT THE LINES HE AND VIDELA HAVE TRACED WILL
BE FOLLOWED STEP BY STEP TOWARDS DEMOCRACY. AND HE
AFFIRMED TO HIS FELLOW INTER-AMERICAN CINCS WHO ARE
MEETING IN BOGOTA THIS WEEK THAT "THERE ARE NO PROBLEMS
IN THE ARGENTINE ARMED FORCES". MEANWHILE, A SPOKESMAN
FOR THE ARMY COMMANDER IN BUENOS AIRES SOUGHT TO REFUTE
MENENDEZ ALLEGATIONS. INTERESTINGLY, A POINT IN
DISPUTE WAS WHO COMMANDED -- AND BY EXTENSION ^{WAS} /RESPON-
SIBLE FOR -- THE ANTI-SUBVERSIVE STRUGGLE. MENENDEZ
IN AN EFFORT TO DIMINISH VIDELA AND VIOLA BEFORE THE
OFFICER CORPS, STATES THAT THE CAMPAIGN WAS CONDUCTED
BY THE "TROOP COMMANDERS" LIKE HIMSELF. VIOLA'S
SPOKESMAN QUICKLY REJOINED THAT THE CAMPAIGN WAS

5. ~~(c)~~ THE POPE'S WORDS ECHO; THE POPE'S REMARKS ON THE DISAPPEARED AND THE DETAINED, AND HIS CALL TO THE ARGENTINE CHURCH TO DEFEND HUMAN RIGHTS CONTINUED TO ECHO IN THE COUNTRY. HUMAN RIGHTS ACTIVISTS HAVE PLAYED BACK THE POPE'S REMARKS TO ENCOURAGE THE GOVERNMENT AND THE CHURCH TO MOVE IN THE DIRECTION THE POPE INDICATED. ON THE OTHER HAND, MEMBERS OF THE GOVERNMENT AND THE ARGENTINE HIERARCHY HAVE SOUGHT TO FUZZ UP THE PICTURE, WHILE SOME OF THEIR MORE CONSERVATIVE ALLIES HAVE BEGUN TO REFUTE THE POPE.

INTERIOR MINISTER HARGUINDEGUY TOLD THE PRESS THAT HE COULD NOT COMMENT ON THE POPE'S REMARKS BECAUSE HE DID NOT KNOW IF THE PRESS REPORTS WERE AN ACCURATE RENDITION OF WHAT THE POPE HAD SAID. (HARGUINDEGUY, ACCORDING TO ONE REPORT, SAID HE HAD ASKED THE CHURCH TO "RATIFY OR RECTIFY THE QUOTE REPORTS," A/XXXXX THAT HAS NOW EMBARRASSED HIM AND CAUSED HIS MINISTRY TO ISSUE A DENIAL). SINCE GENERAL HARGUINDEGUY'S MINISTRY IS RESPONSIBLE FOR TAKING THE ACTIONS THAT WOULD BE REQUIRED IF THE GOA WERE TO RESPOND POSITIVELY TO THE POPE'S CALL, HIS TREATMENT OF THE POPE'S WORDS IS HARDLY ENCOURAGING.

✓ FINALLY, THE RIGHTIST NEWSPAPER, ^{IA}~~LA~~ NUEVA PROVINCIA, HAS EXPRESSED ITS "PAINFUL AND DISAGREEABLE SURPRISE" AT THE POPE'S REMARKS WHICH IT SAID ARE "UNACCEPTABLE" AND ILL-FOUNDED. THE PAPER, WHICH ALL BUT ACCUSED THE POPE OF FALLING INTO A TRAP SET BY INTERNATIONAL COMMUNISM, ALSO QUESTIONED WHETHER JOHN PAUL II NOW CAN BE A MEDIATOR IN THE BEAGLE DISPUTE WITH CHILE.

IN SHORT, THE POPE'S WORDS HAVE NOT YET MOVED THE CONSERVATIVES OF THIS COUNTRY. AND THOUGH, SOME SOURCES EXPRESS A BELIEF THAT AN IMPORTANT STRUGGLE IS SHAPING UP BETWEEN THE CHURCH AND THE GOVERNMENT, THUS FAR THE MAJOR ~~SPYK~~ ^{spokesmen} ~~SPYKESMAN~~ FOR THE CHURCH HERE SEEM TO BE RALLYING AROUND THE GOVERNMENT, TAKING REFUGE IN THE NATIONALISM THAT MARKS THIS COUNTRY. THEY STATE THAT PRIOR TO THEIR RELEASE IN LATE 1978 AND EARLY 1979 ~~THEY~~ ~~XXXXXXXXXX~~ WERE MEMBERS OF A SPECIAL GROUP OF TRUSTEES RECRUITED TO WORK FOR THE NAVY IN GENERAL AND ~~THE~~ NAVY CHIEF ADMIRAL MASSERA IN PARTICULAR. THE REPORT IS CHOCK FULL OF INFORMATION AND ALLEGATIONS. MUCH OF WHAT THE WOMEN SAY WE HAVE HEARD BEFORE, BUT IN FAR LESS DETAIL. THE REPORT'S NEW DEPARTURE IS ITS EXTENSIVE LISTING -- FREQUENTLY BY NAME AND RANK -- ^{ALLEGEDLY} ^{COMMAND} OF THOSE WHO WERE/PART OF THE SCHOOL'S/OPERATIONAL AND INTERROGATION TEAMS. THE REPORT HAS CIRCULATED WIDELY IN EUROPE AND BEEN PICKED UP BY PAPERS THERE BUT THERE HAVE BEEN NO MORE THAN A FEW AND INDIRECT

7. (U) ACTIVE COURT CALENDAR: ARGENTINE COURTS HANDED DOWN A SERIES OF DECISIONS THAT BEAR ON THE HUMAN RIGHTS SITUATION HERE:

-- THE SUPREME COURT OVERTURNED TWO LOWER COURT DECISIONS WHICH HAD ORDERED PEN DETAINEES FREED. THE COURT'S DECISIONS APPEAR TO BE IN LINE WITH PAST PRECEDENTS IN WHICH IT HAS UPHELD THE EXECUTIVES BROAD USE OF ITS PEN POWER.

-- SEVEN PEOPLE ACCUSED OF TERRORIST ACTS IN 1975-1976 WERE GIVEN SENTENCES RANGING FROM ONE YEAR TO LIFE IMPRISONMENT BY A CORDOBA COURT. TWO OTHERS TRIED WITH THEM WERE FREED.

-- ANOTHER CORDOBA COURT ABSOLVED A CORDOBA COUPLE BOTH JEHOVAH'S WITNESSES, WHO WERE ACCUSED BY LOCAL SCHOOL AUTHORITIES OF HAVING INCITED THEIR FIVE AND SEVEN YEAR OLD DAUGHTERS TO REFUSE TO SALUTE THE ARGENTINE FLAG.

-- LOWER COURTS INVOLVED IN HABEAS CORPUS PROCEEDINGS HAVE TWICE RECENTLY ORDERED THE PUBLICATION OF THE PICTURES OF THE DISAPPEARED PERSON AND DESCRIPTION OF THE CIRCUMSTANCES OF THEIR DISAPPEARANCE. THESE ORDERS ARE SOMETHING OF A DEPARTURE FROM THE PAST.

8. ~~(S)~~ DISAPPEARED LAW PROTESTED: HUMAN RIGHTS ORGANIZATIONS WERE TO FILE AN APPEAL TO THE COURTS NOV. 9.

DEATH BE DECLARED UNCONSTITUTIONAL. THE APPEAL, WE ARE TOLD, CONTAINS A BITTER AND STRONG ATTACK ON THE GOVERNMENT'S INTENTIONS AND MOTIVATIONS IN GIVING ITSELF THE AUTHORITY--ALONG WITH FAMILY MEMBERS--TO SEEK A DECLARATION OF PRESUMPTIVE DEATH FOR MISSING PERSONS, EVEN OVER THE OBJECTIONS OF FAMILY MEMBERS. THE LAWYERS WHO HELPED DRAFT THE APPEAL SPOKE TO MARIO AMADEO, THE AUTHOR OF THE LAW AND PRESENTLY THE ARGENTINE NON-GOVERNMENTAL REPRESENTATIVE TO THE UN'S HUMAN RIGHTS COMMISSION. WE UNDERSTAND THAT AMADEO CONVINCED THEM THAT HE HAD NO MALIGN INTENTION IN GIVING THE GOVERNMENT A LARGE POTENTIAL ROLE IN THE DECLARATION OF PRESUMPTIVE DEATH. THEY ALSO LEARNED THAT WHEN AMADEO PRESENTED HIS LAW TO THE GOA, HE INCLUDED SEVERAL OTHER RECOMMENDATIONS, ALL DESIGNED TO IMPROVE THE HUMAN RIGHTS SITUATION IN ARGENTINA AND ARGENTINA'S STANDING IN INTERNATIONAL ORGANIZATIONS. NONE OF THESE WERE ACCEPTED BY THE GOA. OUR SOURCES HAVE NO INFORMATION THAT THE GOVERNMENT HAS MISUSED THE NEW LAW, BUT ARE FEARFUL THAT ONE DAY IT MIGHT. THEY KNOW OF A FEW CASES WHERE FAMILY MEMBERS HAVE USED THE LAW TO HAVE A DISAPPEARED PERSON DECLARED DEAD.
