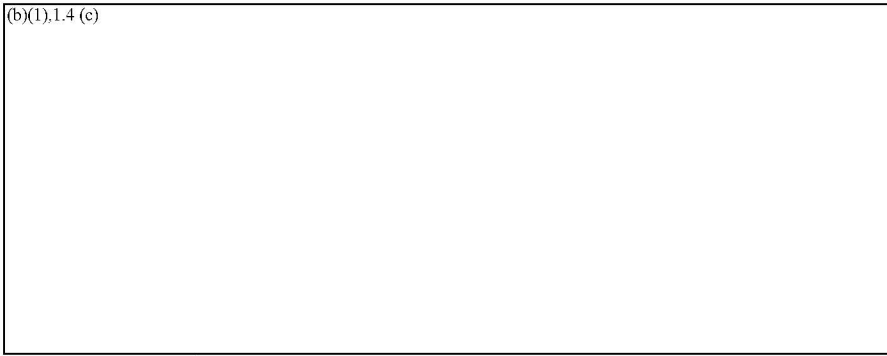
DISCUSSION ON HIS NEW JOB WITH THE INTERAMERICAN DEFENSE BOARD (IADB) IN WASHINGTON, D.C. AND VISAS FOR HIS TWO SONS. THE LOCAL LIMA NEWSPAPERS HAD REPORTED EARLIER LIEUTENANT GENERAL ROBLES HAD BEEN FIRED AS COMMANDER OF INSTRUCTION AND DOCTRINE COMMAND OF THE PERUVIAN ARMY (COINDE). 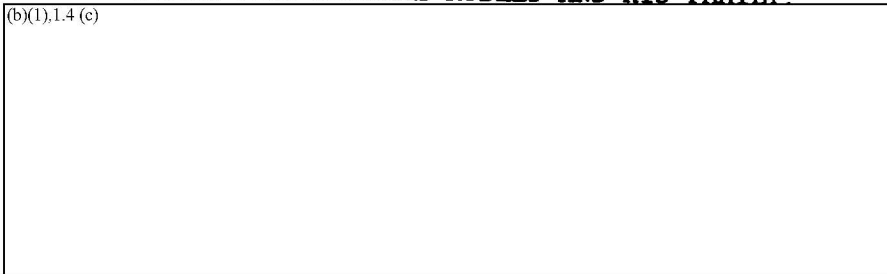
