SUMMARY: (U) TWO BOMBS EXPLODED IN BUENOS AIRES ON 871024,  
ONE IN AN APARTMENT BUILDING HOUSING MILITARY AND THE  
OTHER UNDER THE CAR OF A KOREAN BUSINESSMAN.

TEXT: 1. (U) ON 871024, TWO BOMBS EXPLODED IN BUENOS  
AIRES AR IN A CONTINUING WAVE OF EXPLOSIONS. THE  
FIRST EXPLODED AT MANUEL UGARTE 2158, A 16 FLOOR  
BUILDING LOCATED IN THE NUNEZ NEIGHBORHOOD. THE  
BOMB WAS BETWEEN 150 TO 200 GRAMS OF TROTYL, ACTIVATED  
BY SLOW FUSE, AND PLACED NEAR THE INTERCOM PANEL AT  
THE ENTRANCE. THE BOMB DAMAGED LIGHTS, GLASS AND  
THE FRONT OF THE BUILDING. NO ONE WAS HURT.  
SEVERAL MILITARY RESIDE IN THAT BUILDING, INCLUDING  
COL ENRIQUE ((SCHINELLI)) GARAY AND ARMY INSPECTOR  
GENERAL, GENERAL **ENRIQUE JORGE ((BIANCHI))**. RUMORS

2. (U) THE OTHER BOMB EXPLODED AT 0335 HRS UNDER  
A KOREAN BUSINESSMAN/S RENAULT PARKED ACROSS  
FROM HIS SHOP ON SANCHEZ DE BUSTAMENTE 400 IN THE  
ALMAGRO NEIGHBORHOOD. NOT MUCH DAMAGE WAS REPORTED.

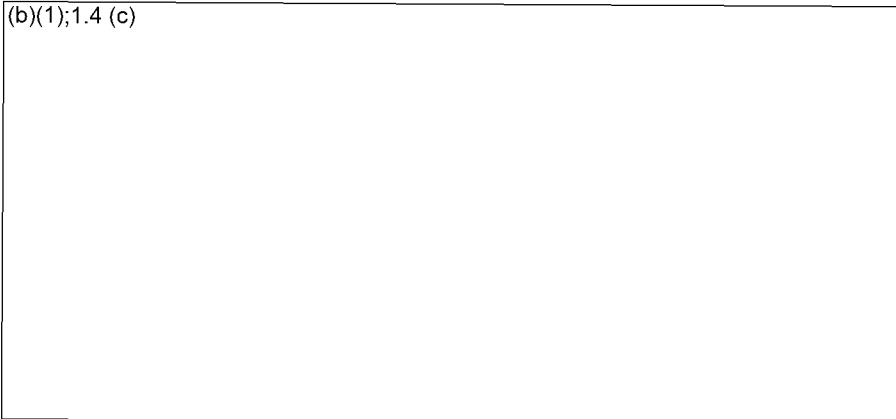

COMMENTS: (SOURCE) 1. (U) THESE TWO INCIDENTS FOLLOW  
AN UPSWING OF BOMBING INCIDENTS. WITHIN THE 48 HOURS  
PRIOR TO THESE INCIDENTS, A BOMB EXPLODED IN FRONT  
OF THE HOME OF A JUDGE AND ANOTHER IN FRONT OF THE  
EX-RESIDENCE OF ANOTHER. (SEE IIR (b)(3):10 USC 42 )  
ANOTHER BOMB EXPLODED, KILLING THE RAILWAY WORKER  
CARRYING IT. ELEVEN DAYS PRIOR TO BOMBING  
INCIDENTS REPORTED IN TEXT, A POWERFUL BOMB  
EXPLODED, PARTIALLY DESTROYING A BUILDING LINKED  
WITH COL ALBERTO ((BORIN)), FUTURE ARMY LEGAL ADVIS )R.  
ALL OF THESE INCIDENTS ARE BELIEVED TO BE INTERPRETED  
AS ACTS OF INTIMIDATION.
