VOCIFEROUSLY OPPOSED THE RECOMMENDATION OF OTHER SENIOR OFFICERS TO REPLACE ALL OF THE SOLDIERS SERVING IN THE POSITION, SAYING THAT IT WOULD SHOW A TOTAL LACK OF CONFIDENCE IN THE TROOPS AND HARM MORALE, HOWEVER, MG MORDECHAI EVENTUALLY DECIDED TO ACCEPT THE RECOMMENDATION AND TRANSFERRED ALL OF TROOPS TO OTHER UNSPECIFIED LOCATIONS. THE ARTICLE SAID THAT THE BRIGADE IS "INFURIATED" BY THE DECISION AND QUOTED A SENIOR GIVATI OFFICER AS SAYING THAT THE ACTION WILL HURT MANY SOLDIERS FOR A LONG TIME, BG "Z.", CG OF THE "GALILEE DIVISION", WAS QUOTED AS CALLING THE SOLDIERS\' ACTIONS "SHEER COWARDICE". HE ALSO STRONGLY CRITICIZED SOME OFFICERS FOR CLOAKING COWARDLY ACTIONS IN EUPHEMISTIC "MILITARY JARGON". BG GIORA ((INBAR)) THE NEW COMMANDER OF THE LEBANON LIAISON UNIT, WAS ALSO SPECIFICALLY MENTIONED IN THE ARTICLE AS SPEAKING OUT FORCEFULLY AGAINST THE CONDUCT OF THE GIVATI SOLDIERS, CALLING THEIR BEHAVIOR "SHAMEFUL".
