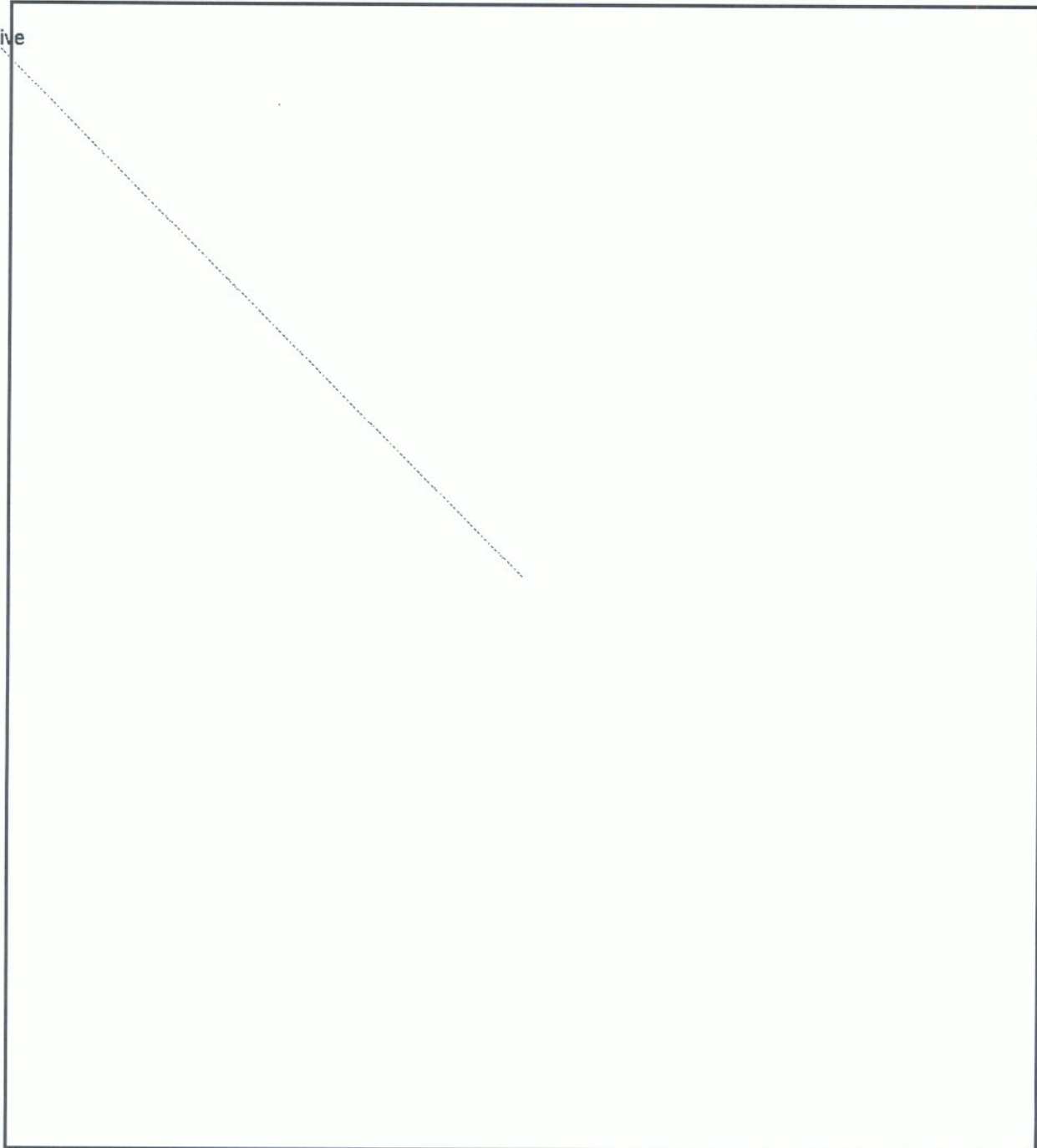

4. (U) IN POLITICAL DEVELOPMENTS, THREE OTHER PARTIES HAVE PUBLICLY REJECTED NELSON MANDELA'S PROPOSAL TO APPOINT PIERRE BUYOYA AS PRESIDENT DURING THE FIRST 18-MONTH TRANSITION PERIOD. CONTRARY TO MANDELA'S 10 JULY ANNOUNCEMENT THAT ALL 19 ARUSHA SIGNATORIES AGREED TO BUYOYA'S TRANSITIONAL PRESIDENCY, AT LEAST 11 HUTU AND TUTSI POLITICAL PARTIES NOW SAY THEY OPPOSED MANDELA'S SELECTION OF BUYOYA.
