1. ~~(S)~~ PEACE TALK FACILITATOR NELSON MANDELA'S COMMENTS HAVE INCREASED TENSION AMONG BURUNDI'S RADICAL TUTSI ELITES.
2. ~~(S)~~ TO PROTEST MANDELA'S PUBLIC CRITICISMS OF TUTSI MILITARY, ECONOMIC, AND POLITICAL DOMINATION, RADICAL TUTSI CONDUCTED AN ILLEGAL DEMONSTRATION ON 26 FEBRUARY IN BUJUMBURA, WHICH RIOT POLICE BROKE UP. THE GOVERNMENT DENIED ORGANIZERS A DEMONSTRATION PERMIT TO PREVENT THE SPREAD OF TENSION AMONG URBAN TUTSI.
3. ~~(S)~~ THE PROTEST WAS IN PART A RESPONSE TO MANDELA'S 21 FEBRUARY PROPOSAL AT THE ARUSHA PEACE TALKS TO INSTITUTE A 50-50 HUTU-TUTSI SPLIT IN A POST-ARUSHA-TALKS ARMY.

ALTHOUGH MANDELA'S INTERVENTION REVIVED MORIBUND PEACE TALKS, HIS CRITICISMS OF THE TUTSI LEADERSHIP, ARMY REFORM PROPOSAL, AND SUGGESTION THAT BUYOYA STEP DOWN COULD CAUSE TUTSI MODERATES AND EXTREMISTS TO QUESTION HIS IMPARTIALITY.
