2. (U) AFTER MEETING WITH HER HUSBAND ON 27 JANUARY, WINNIE MANDELA SAID THAT NEW OBSTACLES ARE DELAYING HER HUSBAND'S RELEASE. SHE CLAIMED THAT NELSON HAS ESTABLISHED A SET OF CONDITIONS THAT WILL RESULT IN HIS RETURN TO THE ARMED STRUGGLE IF THEY ARE NOT

MET BEFORE HE IS RELEASED. ACCORDING TO WINNIE MANDELA, PRETORIA WILL HAVE TO END THE STATE OF EMERGENCY, LEGALIZE THE ANC, PERMIT EXILES TO RETURN TO THE COUNTRY, AND FREE ALL POLITICAL PRISONERS BEFORE NELSON LEAVES PRISON.

3. (U) NONETHELESS, LONGSTANDING ANC LEADER WALTER SISULU, WHO WAS RELEASED FROM PRISON IN OCTOBER, DISMISSED MRS MANDELA'S CLAIMS. HE STATED THAT NELSON MANDELA HAD TOLD HIM HE WAS READY TO LEAVE PRISON. SISULU ALSO SAID THAT PREPARATIONS FOR THAT EVENT ARE CONTINUING.
