C. (U) SOUTH AFRICA: WHITE RIGHT-WING GROUP THREATENS FUTURE ATTACKS. IN A PETITION SENT TO PRESIDENT NELSON MANDELA, THE BOERE BRANDWAG (BOER GUARD) ORGANIZATION THREATENED TO ASSASSINATE MORE PEOPLE IN THE SAME WAY JOHAN HEYNS WAS KILLED, IF MANDELA DID NOT MEET ITS DEMANDS. SUSPECTED WHITE RIGHT-WING EXTREMISTS SHOT HEYNS, A CENTRAL FIGURE IN THE ANTI-APARTHEID MOVEMENT, AT HIS PRETORIA HOME ON 5 NOVEMBER' THE PREVIOUSLY UNKNOWN GROUP COMMANDED MANDELA TO CHANGE THE AMNESTY CUTOFF DATE TO ENSURE THE RELEASE OF WHITE RIGHT-WING EXTREMISTS CURRENTLY BEING TRIED FOR A PRE-ELECTION BOMBING CAMPAIGN IN APRIL 1994. AS THE LAW STANDS, NO CRIMES COMMITTED AFTER 5 DECEMBER 1993 QUALIFY FOR INDEMNITY. THE BOER GUARD ALSO CALLED FOR A REFERENDUM AMONG THE BOER POPULATION TO SHOW THAT THE MAJORITY WANT TO LIVE IN A BOER REPUBLIC AND FOR THE ESTABLISHMENT OF A TRANSITIONAL GOVERNMENT TO FORM A REPRESENTATIVE BOER PEOPLE'S GOVERNMENT. THE PETITION THREATENED THAT IF MANDELA REFUSED TO MAKE A SATISFACTORY ANNOUNCEMENT AND RELEASE WHITE EXTREMISTS, THE GROUP WOULD TAKE ACTION AND MANDELA WOULD DIE. WITH THE EXCEPTION OF THE HEYNS ASSASSINATION, WHITE RIGHT-WING EXTREMISTS HAVE BEEN RELATIVELY QUIESCENT SINCE THE ELECTIONS AND APPEAR TO .  
HAVE LOST MOST OF THEIR POPULAR SUPPORT. NEVERTHELESS, THE TRIAL OF THE BOMBERS MAY LEAD TO RENEWED TERRORIST ACTIVITY FROM THE MOST EXTREME GROUPS, WHO ARE LIKELY TIRED OF WAITING FOR A DECISION ON THE ALL-WHITE HOMELAND ISSUE AND A CHANGE IN THE AMNESTY LAW.
