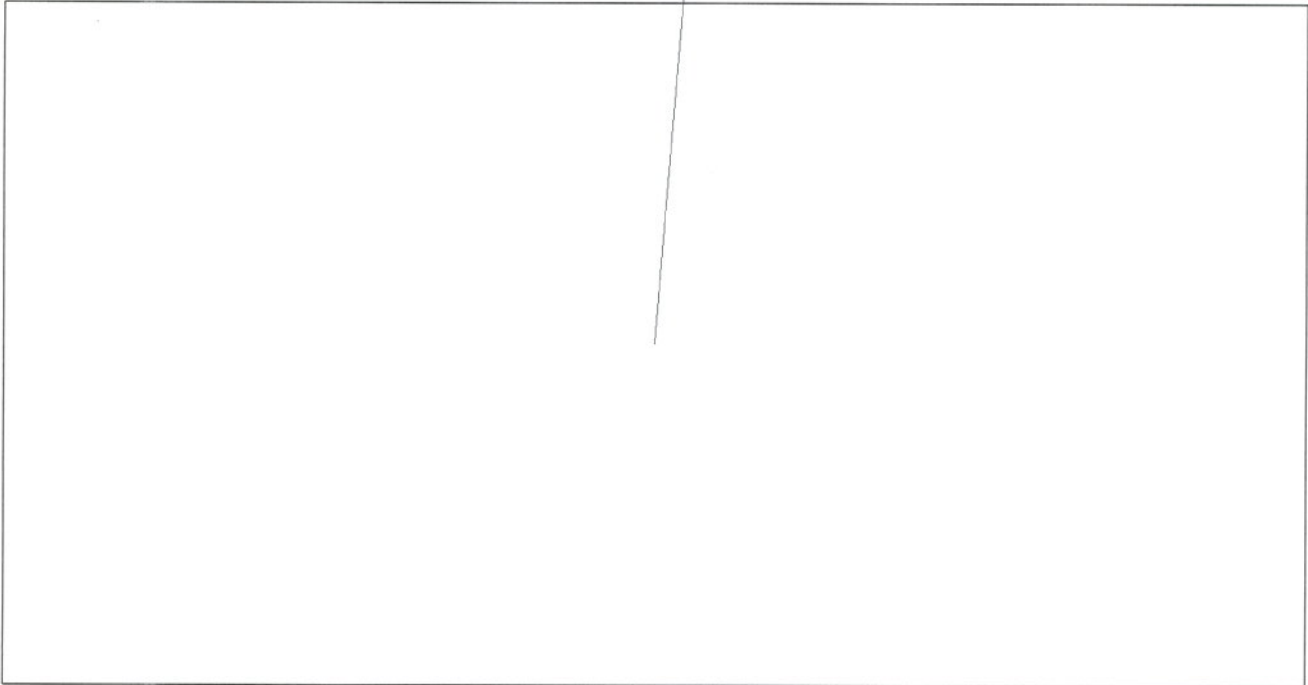

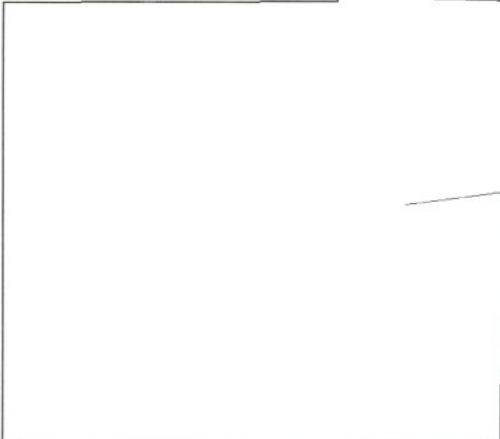

SUMMARY: (C) SOUTH AFRICA IS COMMITTED TO HEADING A JOINT  
AND COMBINED MILITARY ASSESSMENT TEAM TO BURUNDI TO ASSESS  
THE POSSIBILITY OF PROVIDING PEACEKEEPING SUPPORT.

TEXT: 1. (C) IN RESPONSE TO A CALL FROM SOUTH AFRICAN  
EX-PRESIDENT NELSON ((MANDELA)), DEFENSE MINISTER ((LEKOTA))  
CALLED MINISTERS AND EXPERTS FROM BELGIUM, BURUNDI, GHANA,  
NIGERIA, AND SENEGAL TO PRETORIA TO NEGOTIATE A PROPOSAL TO  
PROVIDE PEACEKEEPERS TO BURUNDI. [redacted] THE TEAM  
WOULD BE BOTH COMBINED AND JOINT IN COMPOSITION AND THAT  
MINISTER LAKOTA KEPT THE PARTICIPANTS AT WORK UNTIL THAT ALL
