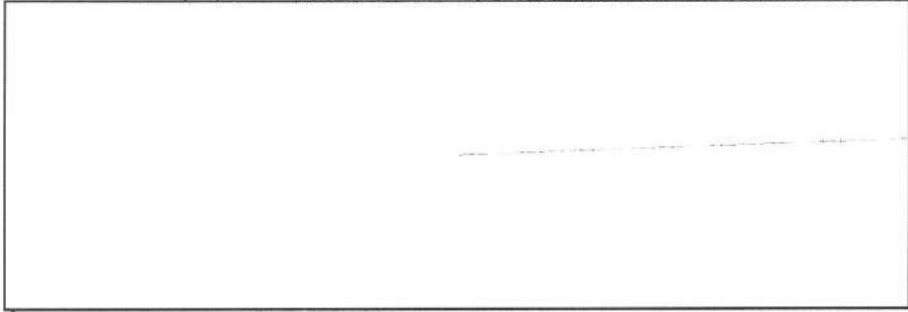

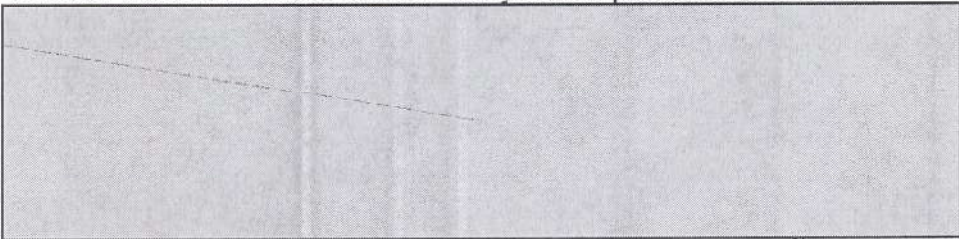

TEXT: 1. (S) [REDACTED] EXECUTIVE SUMMARY. As of 4 December 2013, the South African Department of International Relations and Cooperation (DIRCO), to whom responsibility was given to conduct and execute the government plan post-mortem of former South African President Nelson Mandela, had failed to give the South African National Defense Force (SANDF) their taskings to execute the plan.

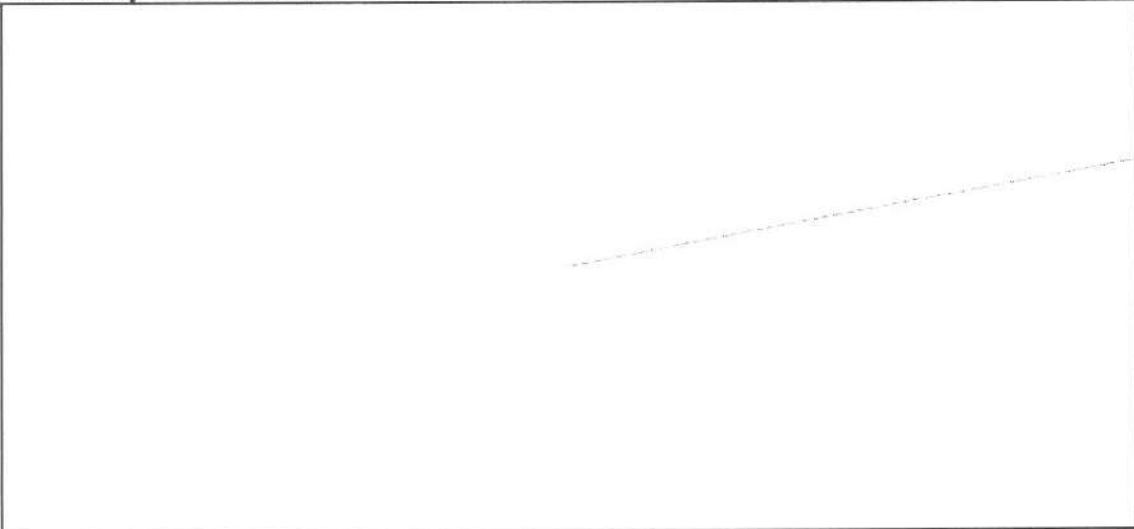

2. (S) [REDACTED] As of 4 December 2013, formal responsibility for contingency planning for the death of former South African President Nelson Mandela still resided with the South African Department of International Relations and Cooperation (DIRCO). The South African National Defense Force (SANDF) would remain in a supporting role upon the death of Mandela based on tasks outlined by DIRCO. Those tasks to the SANDF had yet to be published to SANDF.

SANDF DI were concerned about was whether DIRCO was going to allocate money to SANDF to execute the plan, and concern that planning for the death of Mandela was not moving forward because of cultural prohibitions regarding planning or discussing a person's funeral before they were deceased.
