(C) [redacted] The South African National Defence Force (SANDF) was given responsibility to develop a contingency plan for necessary government actions following the death of former president Nelson ((MANDELA)). Major General Les ((RUDMAN)) was assigned as the lead for a Joint Task Force to plan and coordinate operations and logistics required for a Mandela funeral, ceremonies and burial.

3. (C) [redacted] There will be a funeral service held in Johannesburg at the FNB stadium [redacted]

The burial ceremony will be conducted near Mandela's home in Qunu [redacted] Attendance at the burial ceremony for foreign heads of state and dignitaries will be by invitation only. The USG is not likely to receive an invitation to the burial ceremony in Qunu.

4. (C) [redacted] A SANDF planning assumption is that approximately 100 foreign heads of state will converge on South Africa for the funeral of Nelson Mandela. The Joint Task Force has examined available airports and developed a plan for landing and hangar space for VIP aircraft as well as ground transportation routes and convoy procedures. Any details of the plan are being kept close hold within SANDF due to the sensitivities of discussing Mandela's funeral arrangements while he is still alive.
