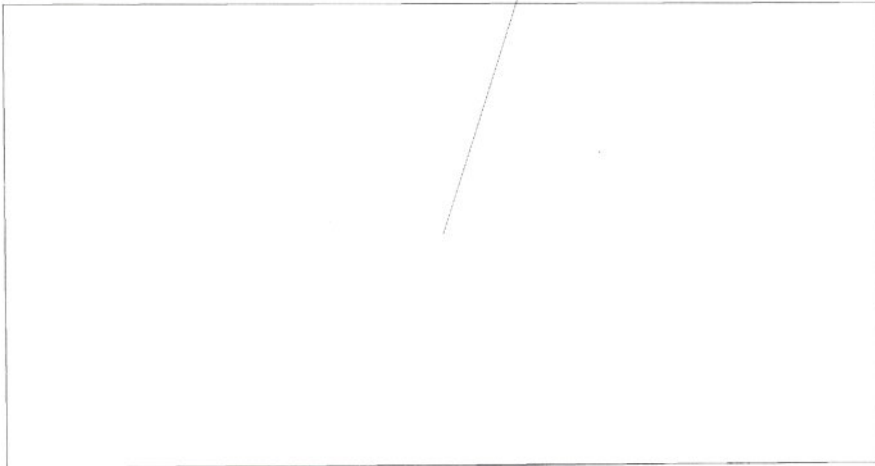

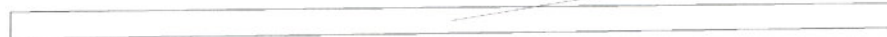

INSTEAD OF ADHERING TO THE ORIGINAL AGENDA AGREED UPON BY ALL PARTIES DURING THEIR MARCH 97 CONFERENCE, NEW INITIATIVES WERE INTRODUCED, PARTICULARLY BY DUP AND UMMA MEMBERS, IN AN ATTEMPT TO SET A NEW COURSE FOR THE ORGANIZATION. DURING THE MARCH CONFERENCE, A COMMITTEE WAS FORMED, COMPOSED OF A MEMBER FROM EACH OPPOSITION GROUP, TO STUDY AND MAKE RECOMMENDATIONS ON SEVERAL IMPORTANT ISSUES ABOUT PRESENT AND FUTURE CONCERNS OF THE NDA. THE LEADERS OF EACH NDA GROUP, COLLECTIVELY KNOWN AS THE SUPREME COUNCIL, WERE TO DISCUSS AND THEN VOTE ON THE COMMITTEE'S FINDINGS DURING

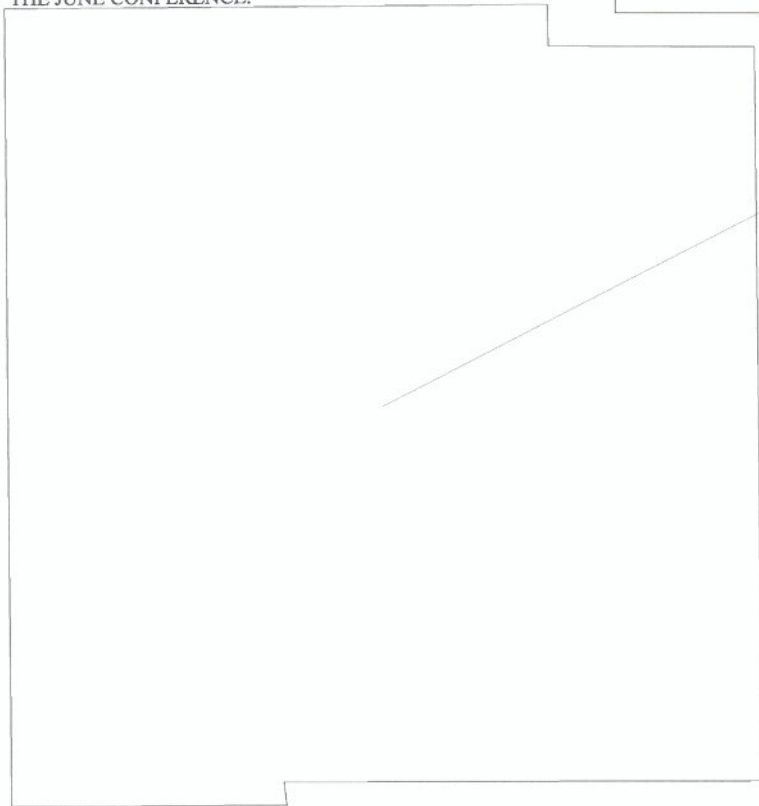

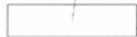
