ALLEGES THAT ORIGINAL REPORTS CLAIMING AN AVIATION BRIGADE COMMUNICATIONS NCO HAD BEEN ASKED BY BG JAVIER ENRIQUE ((REY)) NAVAS, THE COLAR AVIATION BRIGADE COMMANDER, TO FILM

A LOCAL TELEVISION PRESS SERVICE. CLAIMED THAT BG REY'S CAREER IN THE MILITARY WAS PUT IN JEOPARDY BY GENERAL MONTROYA.
