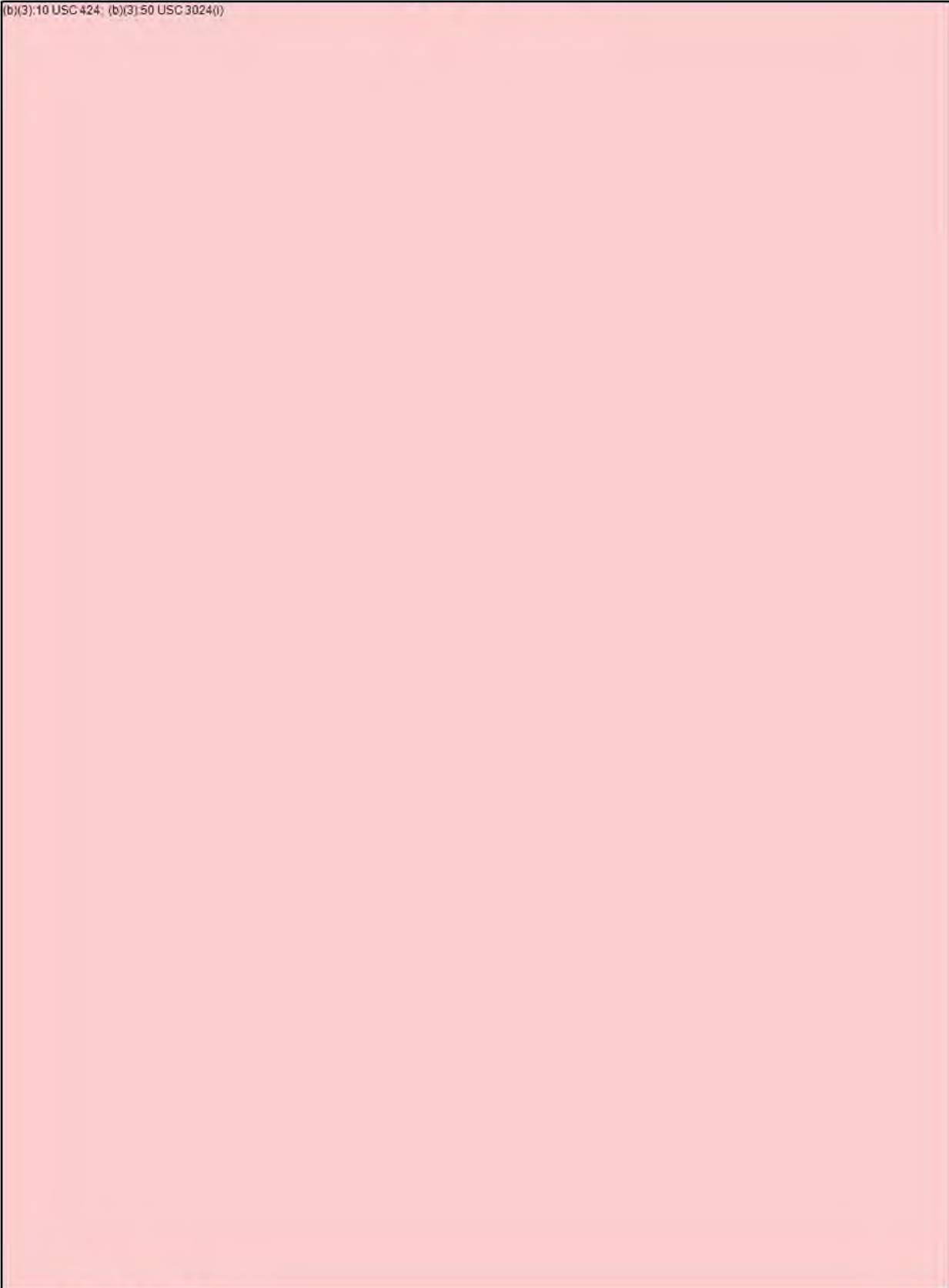

((LOPEZ)) NUILA, DIRECTOR GENERAL OF THE NATIONAL POLICE,
